Young At Heart Rules

- 1. The *Promotion* is valid at the following four (4) participating properties: The Orleans, Gold Coast, Suncoast and Sam's Town every Wednesday beginning January 8, 2014 through December 24, 2014.
- 2. Participants must be B Connected members and must be at least fifty (50) years of age. B Connected membership is free and available at the B Connected Club.
- 3. Participants may earn a Mystery Point Multiplier (up to fifty (50) times points) each Wednesday from 7:00 a.m. to 7:00 p.m. during the *Promotion* at any of the four (4) participating properties. Participants must swipe at the kiosk to receive the point multiplier.

- 6. After earning fifty (50) base slot points, participant may swipe at the kiosk to receive a free breakfast or lunch buffet voucher on the Wednesday at the property the points are earned. The kiosk voucher must be claimed by 7:00 p.m.
- 7. After earning one hundred (100) base slot points, participant may swipe at the kiosk to receive a free dinner buffet voucher on the Wednesday at the property the points are earned. The kiosk voucher must be claimed by 7:00 p.m.
