FRIDAY AND SATURDAY KIOSK PROMOTION

- 1. The *Promotion* is valid at the following seven (7) participating properties: The Orleans, Gold Coast, Suncoast, Sam's Town, Fremont, Main Street Station and California.
- 2. Participants must be B Connected members. B Connected membership is free and available at the B Connected Club. Must be 21 years of age or more to be a B Connected member.
- 3. On the following Fridays and Saturdays in February, 2/3, 2/4, 2/10, 2/11, 2/17, 2/18 and 2/24/2017, participants who have earned five (5) base points on slots from 10:00 a.m. through 10:00 p.m. may swipe at the kiosk to receive a prize. Participants must swipe for their prize by 10:00 p.m. on the day the base points were earned.

Final Cash Drawing

- 4. The *Drawing* will be held at each property on Saturday, February 25, 2017.
- 5. Participants may earn entries into the Virtual Drawing at any of the seven (7) participating properties beginning at 3:00 a.m. February 1, 2017 and ending February 25, 2017 at 8:00pm for all properties
- 6. Slot machine players receive one (1) virtual entry for every ten (10) base points earned each day with their B Connected card properly inserted in their machines. Does not include point multipliers, bonus points or point transfers. It is the player's responsibility to make sure their card is properly inserted in the machine.
- 7. Table games will earn one (1) entry for every one (1) hour of rated play with a minimum average bet of \$5 and earn one (1) additional entry for each additional \$5 average bet. It is the player's responsibility to request that their play be rated.

- 12. There is a maximum of 10,000 entries, per day, per person, for the drawing.
- 13. Participants must be present to win and have three (3) minutes to identify themselves once their name has been called. Valid identification and B Connected card is required for all prize winners. Valid identification is defined as a current valid form of one of the following: state issued driver's license with picture, state issued identification card with picture, military identification card with picture, or government issued passport. If winner is not a U.S citizen, a current valid passport or alien registration card is required. After the three (3) minutes have expired, a new name will be drawn until a winner has been identified.
