2017 Lucky Lincoln Rules

- 1. The *Promotion* is valid at the following four (4) participating properties: The Orleans, Gold Coast, Suncoast, and Sam's Town.
- 2. Participants must be B Connected members. B Connected membership is free and available at the B Connected Club. Must be 21 years of age or more to be a B Connected member.
- 3. The *Drawing* will be held at participating properties every Friday and Saturday beginning July 7 July 29, 2017.
- 4. Participants may earn entries into the virtual *Drawing* at any of the four (4) participating properties beginning at 3:00 a.m. July 2, 2017 and ending July 29, 2017 at 6:00 p.m. for Orleans and Sam's Town, and at 8:00 p.m. for Gold Coast and Suncoast.
- 5. Slot machine players receive one (1) virtual entry for every ten (10) base points earned each day with their B Connected card properly inserted in their machines. - 7. Participants may receive 2X bonus drawing entries when they swipe their B Connected card at the kiosk every Thursday in July.
- 8. Participants may receive 15X points on Penny Reels every Thursday in July. Participants must swipe at the kiosk prior to play in order to activate the point multiplier. Points are not valid on select machines marked excluded. It is the player's responsibility to make sure his or her valid B Connected card is properly inserted in the slot machine to receive base points.
- 9. Additional electronic entries may be given as prize through direct mail, e-mail, online or via text message, as well as property-specific entry multiplier days.
- 10. All drawing entries are "virtual" and must be activated (electronically deposited into our virtual drawing drum) at a casino promotional kiosk at the property where entries are earned. Participants must activate their entries at any kiosk at least fifteen (15) minutes prior to the drawing time on the day of the drawing. Entries earned during the fifteen (15) minute period prior to the drawing will not be eligible for activation in that pending drawing. Gold Coast: West end of the casino adjacent to Cornerstone, 8:15 p.m. Participants may activate their entries beginning at 12:00 p.m. on drawing dates.

Sam's Town: The drawing area on the 2nd floor near Bingo, 6:15 p.m. Participants may activate their entries beginning at 12:00 p.m. on drawing dates.

Suncoast: Race and Sports Lounge, 8:15 p.m. Participants may activate their entries beginning at 12:00 p.m. on drawing dates.

- 12. All activated virtual entries are removed from the virtual drawing drum after the final drawing each Saturday at Orleans, Gold Coast, Suncoast and Sam's Town.
- 13. All accumulated earned entries from July 2-29, 2017 will be available for activation on the final drawing on July 29, 2017.
- 14. There is a maximum of 10,000 entries, per day, per person, for the drawing.
- 15. Participants must be present to win and have three (3) minutes to identify themselves once their name has been called. Valid identification and B Connected card is required for all prize winners. Valid identification is defined as a current valid form of one of the following: state issued driver's license with picture, state issued identification card with picture, military identification card with picture, or government issued passport. - 30. By participating in the *Promotion or Drawing*, each winner gives Boyd Gaming permission to take photographs of each winner and use his or her name and/or likeness for advertising and publicity purposes for no compensation.
