

# MAY 2017 Amazing May Swipe & Win

## FRIDAY AND SATURDAY KIOSK PROMOTION

1. The **Promotion** is valid at the following seven (7) participating properties: The Orleans, Gold Coast, Suncoast, Sam's Town, California, Fremont and Main Street Station.
2. Participants must be B Connected members. B Connected membership is free and available at the B Connected Club. Must be 21 years of age or more to be a B Connected member.
3. On the following Fridays and Saturdays in May 5, 6, 12, 13, 19, 20, 26 & 27, 2017, participants who have earned five (5) base points on slots from 8:00 a.m. through 8:00 p.m. may swipe at the kiosk to receive a prize. Participants must swipe for their prize by 8:00 p.m. on the day the base points were earned at the property where they were earned.

## Final Cash Drawing

4. The **Drawing** will be held at select properties on Sunday, May 28, 2017 at 6:15 pm.
5. Participants may earn entries into the Virtual Drawing at any of the seven (7) participating properties beginning at 3:00 a.m. April 30, 2017 and ending May 28, 2017 at 6:00 pm for all properties, except Main Street Station guests can only earn entries until 3:00 pm.
6. Slot machine players receive one (1) virtual entry for every ten (10) base points earned each day with their B Connected card properly inserted in their machines. Does not include point multipliers, bonus points or point transfers. It is the player's responsibility to make sure their card is properly inserted in the machine.
7. Table games will earn one (1) entry for every one (1) hour of rated play with a minimum average bet of \$5 and earn one (1) additional entry for each additional \$5 average bet. It is the player's responsibility to request that their play be rated.
8. Participants may receive additional entries for each day of play during the promotional period based on their card level status. Participants must swipe their cards daily to receive entry or entries.
  - Ruby members receive one (1) entry daily after earning five (5) points on slots or after the first \$5 rated bet on table games.
  - Sapphire members receive three (3) entries daily after earning five (5) points on slots or after the first \$5 rated bet on table games.
  - Emerald members receive five (5) entries daily after earning five (5) points on slots or after the first \$5 rated bet on table games.
9. Participants may receive 2x bonus entries when they swipe their B Connected card at the kiosk every Thursday in May.
10. Additional electronic entries may be given as prize through direct mail, e-mail, online or via text message, as well as property-specific entry multiplier days.
11. All drawing entries are "virtual" and must be activated (electronically deposited into our virtual drawing drum) at a casino promotional kiosk at the property where entries are earned. Participants must activate their entries at any kiosk at least fifteen (15) minutes prior to the drawing time on the day of the drawing. Entries earned during the fifteen (15) minute period prior to the drawing will not be eligible for activation in that pending drawing. See property times listed below to determine when entries become available for activation.
12. **The Orleans, Gold Coast, Sam's Town, Suncoast, California and Fremont** will each hold one (1) drawing where ten (10) winners will be selected in each drawing. Drawing and the cash envelope selections will take place at the following locations and times:
  - The Orleans:** South end of the Race & Sports Book, 6:15 p.m. Participants may activate their entries beginning at 12:00 p.m. on Sunday, May 28, 2017.
  - Gold Coast:** West end of the casino adjacent to the Cornerstone, 6:15pm. Participants may activate their entries beginning at 12:00 p.m. on Sunday, May 28, 2017.
  - Sam's Town:** The drawing area on the 2<sup>nd</sup> floor near Bingo, 6:15pm. Participants may activate their entries beginning at 12:00 p.m. on Sunday, May 28, 2017.
  - Suncoast:** Race and Sports Lounge, 6:15pm. Participants may activate their entries beginning at 12:00 p.m. on Sunday, May 28, 2017.

**California:** 2<sup>nd</sup> floor tournament area, 6:15pm. Participants from the Main Street Station and California Hotel may activate their entries beginning at 4:00 pm on Sunday, May 28, 2017 at the California Only.

**Main Street Station:** entry earning period will be suspended at 3:00 p.m. Sunday May 28, 2017. Guests will need to check in at the California after 4:00 p.m.

**Fremont:** B Connected, 6:15pm. Participants may activate their entries beginning at 4:00 p.m. on Sunday, May 28, 2017.

13. There is a maximum of 10,000 entries, per day, per person, for the drawing.
14. Participants must be present to win and have three (3) minutes to identify themselves once their name has been called. Valid identification and B Connected card is required for all prize winners. Valid identification is defined as a current valid form of one of the following: state issued driver's license with picture, state issued identification card with picture, military identification card with picture, or government issued passport. If winner is not a U.S citizen, a current valid passport or alien registration card is required. After the three (3) minutes have expired, a new name will be drawn until a winner has been identified.
15. In the order their name was drawn, each of the ten (10) winners will be allowed to select one (1) sealed cash envelope from the drawing board. The first winner drawn will go first in each drawing and will select one (1) of thirty (30) sealed envelopes on display, the second person drawn will select from the remaining twenty-nine (29) sealed envelopes, the third person drawn will select from the twenty-eight (28) sealed envelopes and so on until all ten (10) winners have selected an envelope.
16. The cash envelopes will contain prize amounts ranging from \$250 to \$5,000. Additional bonus draws may also be represented in an envelope. In this case, the participant will keep the cash prize already selected, and they will be entitled to a bonus draw. The participant will keep both cash prizes.
17. A person may only be selected to be a player once. No substitution or transfer of prize by winners permitted.
18. Winners are responsible for any and all taxes and other fees. Winners with cumulative winnings of \$600 or more will receive a 1099 tax form.
19. Boyd may disqualify any person for any prize based upon fraud, dishonesty, violation of promotional rules or other misconduct, whether or not related to this Drawing.
20. Boyd reserves the sole and absolute discretion to determine if a player is an "advantage player," and therefore ineligible to participate in the **Promotion or Drawing**, or to have his/her ability to participate in the **Promotion or Drawing** otherwise limited. Any such "advantage player" who is already a B Connected member prior to the commencement of the **Promotion or Drawing** may be notified by Boyd prior to the commencement of the **Promotion or Drawing** of any such ineligibility or limitation determination. Otherwise, any such "advantage player" will be notified by Boyd of any ineligibility or limitation determination as soon as possible after such determination is made. An "advantage player" is described as a skilled or knowledgeable player who will find legal ways to gain mathematical advantages while gambling.
21. Individuals who have entered any government agency self-exclusion program, or have been otherwise excluded from casinos by a government agency or Boyd Gaming or one of its affiliates are not eligible to participate.
22. Anyone activating **Promotion or Drawing** entries for any account other than their own may, at the discretion of Boyd, be excluded from the **Promotion or Drawing** at issue or permanently excluded from all Boyd **Promotions or Drawings**. Further, the holder of the account containing **Promotions or Drawings** that have been activated by a party other than the account holder may, at the discretion of Boyd, also be excluded from the **Promotion or Drawing** at issue or permanently excluded from all Boyd **Promotions or Drawings**.

submissions which may limit, restrict, or prevent a participant's ability to participate in the **Promotion or Drawing**.

If, for any reason, the **Promotion or Drawing** is not capable of running as planned, including infection by computer virus, bugs, tampering, unauthorized intervention, fraud, technical failures, or any other causes within or beyond the control of Boyd which corrupt or affect the administration, security, fairness, integrity, or proper conduct of this **Promotion or Drawing**, Boyd reserves the right, in its sole discretion without notice, to cancel, terminate, modify, or suspend the **Promotion or Drawing**.
25. Any attempt by any person to deliberately damage or manipulate any program or equipment to undermine the legitimate operation of this **Promotion or Drawing** may be a violation of criminal and civil laws and, should such an attempt be made, Boyd reserves the right to seek recourse against any such person to the fullest extent of the law.
26. Entries will be retained for record-keeping purposes in accordance with company policy and legal requirements.
27. Any dispute or situation not covered by these rules shall be resolved by the property's management in a manner that is fair to all parties. Participants in this **Promotion or Drawing** also hereby agree that all issues and questions concerning these Official Rules and the **Promotion or Drawing** shall be governed by Nevada law without giving effect to any principles of conflicts of law of any jurisdiction.   - (B) Filed only in the state or federal courts situated in Clark County, Nevada state, and each participant hereby consents and submits to the personal jurisdiction of such courts for the purposes of litigating any such disputes, claims or causes of action; any and all claims, judgments and awards shall be limited to actual out-of-pocket costs incurred, but in no event attorneys' fees; and under no circumstances will entrants be permitted to obtain awards for third parties, and each participant hereby waives all rights to claim punitive, exemplary, incidental, special, consequential damages and any other damages, other than for actual out-of-pocket expenses, and any and all rights to have damages multiplied or otherwise increased.
28. By participating in the **Promotion or Drawing**, each winner gives Boyd Gaming permission to take photographs of each winner and use his or her name and/or likeness for advertising and publicity purposes for no compensation.
