OFFICIAL RULES

Slot machine players receive one (1) virtual entry for every twenty-five (25) base points earned each day with their B Connected card properly inserted in the slot machine at the Fremont Hotel and Casino. Does not include point multipliers, bonus points or point transfers. It is the player's responsibility to make sure their card is properly inserted in the slot machine. Fremont Hotel & Casino base points earned are valid towards Fremont Hotel and Casino entries earned.
2. **Bonus Entries...** Slot machine players receive **10 times entries on drawing days**. Ten (10) virtual entries for every twenty-five (25) base points earned on Fridays and Saturdays with their B Connected card properly inserted in any slot machine at the Fremont Hotel and Casino.
3. Table games will earn one (1) virtual entry for every one (1) hour of rated play with a minimum average bet of \$5 and earn one (1) additional entry for each additional \$5 average bet. It is the player's responsibility to request that their play be rated on their B Connected card.
4. **Bonus Entries...** Table games players receive **10 times entries on drawing days**. Ten (10) virtual entries for every one (1) hour of rated play with a minimum average bet of \$5 earned on Fridays and Saturdays. It is the player's responsibility to request that their play be rated on their B Connected card.

6. At management's discretion, additional electronic entries may be given through direct mail, email, on-line or via text message as well as property specific entry multiplier days.
7. All drawing entries are "virtual" and must be activated (electronically deposited into our cyber drawing drum) at the kiosks located at the Fremont Hotel and Casino to participate starting at 12:00 pm each drawing day. Winners are selected by the Fremont's automatic drawing system.
8. Slot participants must activate their entries at least fifteen (15) minutes prior to the drawing time on the day of the drawings. Entries earned during the fifteen (15) minute period prior to the drawing will not be eligible for activation in that pending drawing. Five (5) guaranteed winners will be selected at each drawing for a total of ten (10) guaranteed winners each drawing day. Drawings will take place at the Fremont's B Connected Club. Participants may activate their virtual entries beginning at 12:00 pm on each drawing day.
10. The following prizes will be available: **Friday and Saturday Drawings, Ten (10) Guaranteed Winners each drawing day for a total of Forty (40) Guaranteed Winners. One (1) \$50 winner, One (1) \$100 winner, One (1) \$200 winner, One (1) \$250 winner and one (1) \$400 winner will be selected at 5:00 pm and One (1) \$50 winner, One (1) \$100 winner, One (1) \$150 winner, One (1) \$200 winner and one (1) \$1,000 winner will be selected at 7:00 pm from entries earned at the Fremont Hotel and Casino.**

Winners must present a valid ID and their B Connected card. After the three (3) minutes have expired, a new name will be drawn until a winner has been identified.
