\*A single add-on may be taken from the start of the tournament, through the end of the first break. In order to take the add-on, players must have at least one (1) remaining starting chip in front of them. Once a player loses all of his/her starting chips, their only option to remain in the tournament is to re-enter. Re-entries are allowed through the end of the first break only. Those wishing to re-enter will be placed back into the tournament promptly, as long as seats are available. If an alternate list exists, those wishing to re-enter will be placed at the bottom of the alternate list. Management reserves the right to modify or cancel this schedule and structure at its sole discretion and without prior notice.

## **Daily Poker Tournament Rules**

- 1. All participants must be 21 years of age or older.
- 2. Daily tournaments begin at 11:05 am and 7:05 pm daily. Daily tournaments may be canceled during special events and/or holidays. Starting times may also be subject to change.
- 3. Tournament buy-ins are \$60, \$80, \$100, and \$125.
- 4. Tournament entry fees are as follows: \$60/\$80 tournaments \$15; \$100 tournaments \$20; \$125 tournament \$25

  Entry fees are withheld to cover costs associated with the tournament such as beverage service, staffing, and tournament promotional funding.
- 5. Players will start with 6,000 in chips for the \$60 tournaments, 8,000 in chips for the \$80 tournaments, 10,000 in chips for the \$100 tournaments, and 12,500 in chips for friday night's \$125 tournament. For tournaments with add-ons, 2,000 in chips will be given for the add-on.
- 6. A single add-on may be taken any time from the start of the tournament, through the end of the first break. Players must have at least one (1) remaining starting chip in order to take the add-on. If a player loses all of his/her starting chips, their only option to remain in the tournament is to re-enter, as long as the re-entry period is still open (see rule #7).
- 7. Re-entries are allowed in all tournaments through the end of the first break only. Re-entries will be assigned a seat promptly if there are seats available. If an alternate list exists, re-entries will be placed at the bottom of the alternate list.
- 8. Players are eliminated from the tournament once all of their starting chips have been relinquished, their add-on has been exhausted (if applicable), and the re-entry period has ended.
- 9. Player agreements regarding prize pool payouts (chops) are permissable, as long as the agreement is unanimously and willingly decided upon by all remaining participants.
- 10. As players are eliminated from the tournament, the tournament floor will keep the tables balanced according to Orleans tournament procedures.
- 11. A form w2-g will be issued to those that net more than \$5,000. The buy-in amount is deducted from the winnings. Non-resident aliens are subject to a 30% withholding, and will be issued a form 1042s.
- 12. All winners must produce a valid I.D. and social security card/number for net winnings of more than \$5,000, minus the buy-in.
- 13. Management reserves the right to limit the number of entrants based on table availability.
- 14. Management reserves the right to cancel, or make revisions to daily tournaments and structures at its sole discretion, and without prior notice.
- 15. Penalties may be imposed to anyone found not in compliance with Orleans general rules, tournament rules, and/or inappropriate behavior. If the issuance of penalties do not provide corrective action, an individual may be subject to disqualification, at the discretion of the tournament floorperson. A disqualified patron will forfeit all monies he/she has contributed, as well as rights to any portion of the prize pool.
- 16. Any dispute or situation not covered by these rules shall be resolved by the property's management in a manner that is fair to all parties. If the patron is not satisfied with management's decision, he/she may exercise their rights under nrs 463.362 et eq., and request the nevada gaming control board to review the matter.
