

2017 PICK THE PROS CONTEST RULES - REVISED

- 1. As used herein, "Boyd" means Boyd Gaming Corporation.
- 2. Kansas Star Casino will be conducting a weekly contest open to all B Connected/Lucky Star Players Club members . This contest will be made available during the 17 weeks of the regular Pro Football season. Contestants will be able to win cash and prizes weekly as well as over the course of the season.
- 3. All contestants must be B Connected/Lucky Star Players Club members. Entry is FREE.
- 4. Membership in B Connected/Lucky Star Players Club is free and is available at the B Connected /Lucky Star Players Club for those at least 21 years of age.
- 5. The contest will be administered at approved MGT kiosks located in the Kansas Star Casino.
- 6. Contestants need to activate their registration and accept the terms and conditions of the contest at the kiosk. This will be their valid contest registration for the entire season.
- 7. Registration for the contest begins Tuesday, August 29, 2017 at 7:00 p.m. at which time contestants may also enter their picks for week one (1) of the contest.
- 8. Each week all members will be given one (1) free set of picks. Anyone with more than one (1) set of picks will be disqualified for that week.
- 9. Each week's contest picks may be entered no earlier than 7:00 p.m., each Tuesday, and no later than noon the following Sunday, with the exception of week 16, in which case entries must be turned in no later 12:00 p.m. Central time on Sunday, December 24th.
- 10. Any game played in England or Mexico City are not included as part of the weekly pick.
- 11. Contestants must register <u>in person at the kiosk</u>. Valid B Connected/Lucky Star Players Club members must enter their PIN (personal identification number) each time the B Connected/Lucky Star Players Club card is swiped at the kiosk.
- 12. Each week, contestants will enter their picks and a score in the selected tie-breaker game via a touch screen selection at the kiosk. Once an entry is selected it will appear with all "Favorites" marked on the entry and a tie-breaker amount. Before submitting their picks, contestants will have the option of changing any of the selections on the entry, as well as changing the prepopulated tie-breaker. Contestants will also have the option of using a "Quick Picks," a "Home Team," or a "Favorites" button. The "Quick Picks" button will automatically make the selections randomly. The "Home Team" button will select teams that are scheduled to play at home at the time the promotion begins each week. The "Favorites" button will automatically select the teams who are favored according to the point spreads assigned to the teams at the time the promotion begins each week. For Pick'em games, where there are no point spreads, the Home Team will be considered the Favorite. Contestants may then change any or all of the selections before submitting.
- 13. Once the contestant selects the submit button for each one of their picks, the pick is final and changes will not be permitted. It is the player's responsibility for verifying the accuracy of their picks prior to selecting the submit button. Once the pick has been submitted via the kiosk, a paper copy of their picks will be generated at the kiosk. If a copy of the picks is not generated, contestant may go to the B Connected/Lucky Star Players Club to get a printed copy of their picks. A printed copy of the picks is not required to win.
- 14. The contest involves picking the winning teams of selected games during each week for the Pro Football 2017 regular season's Sunday and Monday games (maximum 16 games during any one (1) week). The contest runs from week #1 of the 2017 regular season through week #17 of the

- 2017 regular season. With the exception of week 16, which will consist of that week's Saturday, Sunday and Monday games.
- 15. For contest purposes, there are <u>no point spreads</u> on any of the football games. **Point spreads presented on the kiosk are informational only.** The team winning the game is the winning selection. In the case of a tie, either team selected will count as a win. If a Sunday game that is initially part of the contest at the time the promotion begins each week is subsequently postponed until a date beyond the following Monday, then both sides of that game will count as a win. If the Monday night game is canceled or postponed beyond Monday, then either team selected will count as a win.
- 16. **Weekly Prize Contest:** Prizes will be awarded each week to all contestants based on their weekly rank, which will be determined by their total number of correct picks for the week. In the case of ties:
 - a. **The first tie-breaker:** The contestant who comes closest to picking the combined score on that weekend's selected tie-breaker game will receive the higher rank.
 - b. **The second tie-breaker:** If the first tie-breaker does not determine rank, the contestant with the earliest electronic time stamp that is generated by the kiosk for that week's contest will receive the higher rank.
- 17. Possible prizes associated with weekly ranking are as follows:
 - a. **Rank 1 thru 10**: Possible prizes are \$1,000 in Slot Dollars, \$500 in Slot Dollars, \$250 in Slot Dollars, \$100 in Slot Dollars, \$50 in Slot Dollars, \$25 in Slot Dollars, \$20 in Slot Dollars, \$15 in Slot Dollars or \$10 in Slot Dollars. Prizes will be awarded randomly at any Kansas Star Casino Promotional Kiosk.
 - b. **Rank 11 thru 100**: Possible prizes are \$100 in Slot Dollars, \$50 in Slot Dollars, \$25 in Slot Dollars, \$20 in Slot Dollars, \$15 in Slot Dollars, \$10 in Slot Dollars or \$5 in Slot Dollars, 1,000 Slot Points or 500 Slot Points. Prizes will be awarded randomly at any Kansas Star Casino Promotional Kiosk.
 - c. Unranked: Possible prizes are: \$50 in Slot Dollars, \$25 in Slot Dollars, \$20 in Slot Dollars, \$15 in Slot Dollars, \$10 in Slot Dollars or \$5 in Slot Dollars, 1,500 Slot Points, 1,000 Slot Points, 500 Slot Points, 100 bonus entries into the monthly mass promotion when applicable, Buy one, get one free buffet voucher, Discount voucher for the Kansas Star Gift Shop, or Discount voucher for Show tickets at the Kansas Star. Prizes will be awarded randomly at any Kansas Star Casino Promotional Kiosk. Prizes will vary throughout the promotion.
- 18. In the event that the number of contestants with the same number of winning picks during any one (1) week of the contest exceeds one hundred (100), the tie-breaker rules outlined in rule #16 will be utilized to determine contestant rank. In that event all contenstants exceeding one hundred (100) will become part of the "Unranked" pool. Under no circumstance will Kansas Star Casino be required to award a ranking to more than one hundred (100) contestants for any one (1) week of the contest.
- 19. Contestants may inquire at the B Connected Club/Lucky Star Players Club or check online when the "Kansas Star Players Club" is converted to "B Connected" after 7:00 pm each Tuesday to see how he/she ranked.
- 20. Contestant may claim weekly prize at any kiosk from 7:00 pm Tuesdays through 10:00 pm Thursdays based on the previous week's results. (Example Week two's prizes, for the September 17/18 games, are available to claim beginning on September 19, at 7:00 pm through 10:00 pm Thursday, September 21). Prize awarded will be one (1) of the possible prizes based on contestant's weekly rank as specified in rule #17. Prizes not timely claimed will be forfeited.
- 21. **Season MVP**: Weekly rankings will be tracked throughout the contest to determine a Season MVP. This contestant will be awarded with \$5,000 cash and a trophy at the season finale.
 - a. Determination of the MVP will be based on a cumulative points rating system in which ranked contestants will receive a point value for their weekly rank.

- b. The points assigned to each weekly rank will be awarded in a reverse order (i.e. Rank one (1) receives one hundred (100) points and Rank one hundred (100) receives one (1) point). Unranked contestants will receive a point value of zero (0).
- c. The contestant with the highest cumulative point total at the end of the regular season will be named the MVP.
- d. Prizes will be given out to the top 5 contestants on January 6, 2018 at 4pm. The winners do not need to be present to win. A representative of the Kansas Star will contact the winner by phone or email. Prizes must be claimed by January 31, 2018.
- 22. The top 5 contestants on the leaderboard will receive the following prizes:

Prize Structure

MVP \$5,000 cash

2nd Place \$2,500 Slot Dollars

3rd Place \$1,000 Slot Dollars

4th Place \$500 Slot Dollars

5th Place \$250 Slot Dollars

If there is a tie for any position, the cumulative prize total of the places that are tied will be split equally among the players that are tied.

- 23. Prizes can only be claimed by the winning contestant in person with valid photo identification. No winnings, under any circumstances, will be mailed.
- 24. \$100,000 Prize Pool: Contestants who make at least twelve (12) correct picks of games that week in each of at least fifteen (15) different weeks will be eligible for a \$100,000 cash prize. In the event that multiple winners are eligible for the \$100,000 prize it will be equally split between all eligible contestants. The \$100,000 cash prize will be paid monthly over the course of one year. If no one qualifies, the \$100,000 prize will not be distributed.
- 25. Winners are responsible for any and all taxes and other fees.
- 26. Boyd may disqualify any person for any prize based upon fraud, dishonesty, violation of promotional rules or other misconduct whether or not related to this *Contest*.
- 27. Boyd is not responsible for (a) electronic transmission errors or delays resulting in an inability to participate or other loss, (b) theft or destruction of or unauthorized access to or alterations of entry materials, or for technical, hardware, software, or telephone failures of any kind, (c) lost or unavailable connections, fraud, incomplete, garbled, or delayed computer transmissions, whether caused by Boyd, users, or by any of the equipment or programming associated with or utilized in the promotion or by any technical or human error which may occur in the processing of submissions which may limit, restrict, or prevent a contestant's ability to participate in the *Contest*.
- 28. If for any reason the *Contest* is not capable of running as planned, including infection by computer virus, bugs, tampering, unauthorized intervention, fraud, technical failures, or any other causes within or beyond the control of Boyd which corrupt or affect the administration, security, fairness, integrity, or proper conduct of this *Contest*, Boyd reserves the right in its sole discretion to cancel, terminate, modify or suspend the *Contest* with approval of the Kansas Lottery and the Kansas Racing and Gaming Commission
- 29. Any attempt by any person to deliberately damage or manipulate any program or equipment to undermine the legitimate operation of this *Contest* may be a violation of criminal and civil laws, and should such an attempt be made, Boyd reserves the right to seek recourse against any such person to the fullest extent of the law.
- 30. Entries will be retained for record keeping purposes in accordance with company policy and legal requirements.
- 31. Any dispute or situation not covered by these rules shall be resolved by the property's management in a manner that is fair to all parties.
- 32. All contestants agree to grant Boyd Gaming unconditional use of their name and likeness for promotional use without compensation, consideration, notice review or consent.
- 33. Employees of Boyd Gaming and immediate family members are not elegible. Employees of Micro Gaming Technologies Inc., Kansas Star Casino employees, along with their immediate family and Boyd Gaming employees whose job functions restrict them from gaming at any Boyd Gaming

property and its subsidiaries, affiliates, or parent companies are not eligible for this promotion. Immediate Family is defined as: mother, father, spouse, children, sister, brother, son-in-law, daughter-in-law, mother-in-law, father-in-law, step-parents, step-children, grandmother, grandfather, grandchildren and any relative or other person residing in the employee's place of residence.
