RULES

1. All participants must be 21 years of age, and a B Connected member. The tournament will be limited to the first 144 people that register.
2. You only need to complete one card to participate, but here's the twist, for every additional completed card, you will earn \$25 in additional tournament chips "STASHED CASH". Those chips can be used prior to ANY round as additional tournament chips. Prior to the round, the dealer will ask if anyone wishes to use their "STASHED CASH", you will not have this opportunity again for the remainder of that round. At that time the dealer will ask for your "STASHED CASH" card and deduct the amount of chips you want to use for that round of play. You can use a portion or the entire amount of chips that are on the card, in \$25 increments. Those chips cannot be replenished. If your "STASHED CASH" chips are not used, they will be forfeited. If you do not qualify for the next round, those chips will be forfeited. Remaining "STASHED CASH" may be used for the duration of the tournament, including the final table.
3. A B Connected member can earn a spot in the tournament by completing one card and presenting it at registration on Thursday and Friday, July 27 & 28, 2017.
4. STASH YOUR CASH cards can only be earned at Suncoast, beginning Friday, June 30, 2017 at 12:01am and ends on, July 29, 2017 at 11:59pm. Receive one stamp for every qualifier. Qualifiers are:
 - Blackjack (type games): Every suited Blackjack (first 2 cards), with a minimum \$10 bet
 - Blackjack (type games): A winning "Bet the Set" bet.
 - Carnival Games and Roulette: 20 minutes play, with a minimum \$10 bet.
 - Craps: 20 minutes play, with a minimum \$10 bet or a winning Repeater bet
5. All games based on time, the floor supervisor in your section will determine the number of stamps at the end of rated play. It is the guest's responsibility to request their play rated.
6. Additional STAMPS may be earned through midnight on Saturday for players that have REGISTERED. Double stamps can be earned Fridays and Saturdays throughout the qualifying period, from 6pm until midnight.
7. STASH cards will be distributed throughout the table games area. Before you receive stamps on your card, you must fill out the card with your B Connected number and name. The STASH card needs five stamps to be completed. Once completed, the card is eligible to be used for entry into the tournament or \$25 in "STASHED CASH".
8. Suncoast will guarantee a prize fund of \$15,000 consisting of (1st) \$5,000, (2nd) \$2,500, (3rd) \$1,500, (4th) \$950, (5th) \$650, (6th) \$400. After the final round is completed on Sunday, July 30, 2017, we will have a drawing to give away (8) \$500 prizes.
9. Registration will take place from Thursday and Friday, July 27 & 28, 2017 in the table games area from 9am to 9pm. At the time of your registration, you can purchase \$250 in extra "STASHED CASH" for a \$5 fee. At this time, you will need to present one completed card (which must contain your B Connected number, name, address, phone number and email address) to registration. This card earns your entry and will be placed in a drawing drum for the drawings that will be held after the final round of play. At this time you will schedule your play time and receive your seating assignment for Sunday, July 30, 2017, with the first round starting at 10:00am.
10. Please arrive to the tournament area 15 minutes prior to the start of your session time. "STASHED CASH" will be totaled at registration and the day of the tournament prior to your scheduled play time. Please bring any completed cards at the time of registration.
11. The tournament format is elimination. As an entrant, you will play in one (1) 15 hand session with \$1000 in non-negotiable, non-redeemable tournament chips (not counting your "STASHED CASH"). If you qualify, you will play in subsequent round(s). Each contestant will have a grace period of 3 hands in case of tardiness (a forfeit of \$10 per hand will be assessed).
12. SECOND CHANCE DRAWING - after the first round of play, everyone that didn't qualify for the next round will deposit their "STASHED CASH" seating assignment card with their printed name on it, into the drawing drum (names must be legible or will be discarded). We will draw 4-8 names to play in the subsequent rounds, to be determined after tournament format is distributed on Saturday, July 29, 2017 after 1pm.
13. All tournament play will be dealt from a six deck shoe, with standard hand signals for hitting or standing. (Dealers will be instructed to have a clear and distinguishable signal from the entrant).
14. No strategy cards will be permitted.
15. Players are not allowed to "Sit Out" any hands during tournament play. Minimum bet is \$10. All bets should be in \$10 increments with a maximum wager of \$1,000. A remaining \$5 chip will be counted at face value for scoring only and should not be wagered in play. (In any cases where "Breakage" occurs, it will be to the house advantage, and payouts will be rounded to the closest possible increment.)
16. All entrants should arrive at their assigned table for seating five minutes ahead of scheduled start times. A zero score will be given in those cases where the entrant was unable to participate.
17. Each round will consist of 15 hands. After completion of the 12th hand, and before the 13th hand, the dealer will count down each entrant's chips in view of all other players at the table. No other formal count will occur until the conclusion of the 15th hand. It will be the entrant's responsibility to estimate the other player's bank.
18. From a single die, the number rolled will determine the beginning 1st base position. Subsequent hands will be dealt with a rotating 1st base position going in a clockwise rotation. All bets should be wagered in turn beginning with 1st base, in a clockwise rotation. Once wagered, and placed in the betting area, no adjustments may be made to increase or decrease the original wager.
19. Suncoast's normal Blackjack rules will apply.
20. Players are not to collaborate or consult with spectators, or assist in the decision making of other player's hands that are in currently in action.
21. Any hand that meets the following criteria will result in the entire hand being burned: cards dealt out of order, customers or dealer receiving more or less than two cards.
22. All winners must show their B Connected card and proper ID to be verified.
23. Entries are non-transferable.
24. Management reserves the right to modify or cancel this promotion at any time.
25. Accumulative winnings over \$600 for the year will receive a 1099.
26. Boyd may disqualify any person for any prize based upon fraud, dishonesty, violation of promotional rules or other misconduct, whether or not related to this promotion.
27. Boyd reserves the sole and absolute discretion to determine if a player is an "advantage player," and therefore ineligible to participate in the Promotion, or to have his/her ability to participate in the Promotion otherwise limited. 28. Individuals who have entered any government agency self-exclusion program, or have been otherwise excluded from casinos by a government agency or Boyd Gaming or one of its affiliates are not eligible to participate.
29.
