

- 1. The Drawings are valid at Suncoast Hotel & Casino Only.
- 2. Drawings will be held at the property on Fridays & Saturdays on the following dates: August 4, 5, 11, 12, 18, 19, 25 and 26, 2017.
- 3. Participants must be B Connected members. B Connected membership is free and available at the B Connected Club. Must be 21 years of age or more to be a B Connected member.
- 4. Participants may earn entries into the Virtual Drawing beginning at 2:00am Sunday, July 30, 2017 and ending Saturday, August 26, 2017 at 8:00pm.
- 5. Slot machine players receive one (1) virtual entry for every ten (10) base points earned each day with their B Connected card properly inserted in their machines. Does not include point multipliers, bonus points or point transfers. It is the player's responsibility to make sure their card is properly inserted in the machine.
- 6. Table games will earn one (1) entry for every one (1) hour of rated play with a minimum average bet of \$5 and earn one (1) additional entry for each additional \$5 average bet. It is the player's responsibility to request that their play be rated.
- 7. Participants may receive 10x bonus entries when they swipe their B Connected card at the kiosk on Thursdays, August 3, 10, 17 & 24, 2017.
- 8. Additional electronic entries may be given through direct mail, e-mail, online or via text message, as well as property-specific entry multiplier days.
- 9. All drawing entries are "virtual" and must be activated (electronically deposited into our cyber drawing drum) at a casino promotional kiosk at the property where entries are earned. Participants must activate their entries at any kiosk at least fifteen (15) minutes prior to the drawing time on the day of the drawing. Entries earned during the fifteen (15) minute period prior to the drawing will not be eligible for activation in that pending drawing. Entries earned during and after the fifteen (15) minute cutoff are eligible for the next available drawing. See property times listed below to determine when entries become available for activation.
- 10. The Suncoast will hold two (2) nightly drawing where five (5) winners will be selected in each drawing. Drawings will take place at the following location and times:

- I5. Each winner will be given a chance to roll a pair of dice to determine their cash prize. The pair of die consist of one with dollar prizes of \$100, \$125, \$150, \$175, \$250 & \$500 and one with a Multiplier 1X, 2X and 3X. The combination of the two tops of the dice will determine the prize, up to \$1,500 cash. For example if the dice end up showing \$500 and 3X, on the top of the die, the prize would be \$1,500 cash.
- 16. Dice will be set on the top starting step to begin the roll. For the Dice indicating the dollar amount, the \$100 will show the top. On the prize multiplier die, a 3X will be displayed on the top to begin the roll. The participant will release dice and allow them to tumble down steps. Once dice are placed in the starting position, participants may not handle or lift the dice. All die must roll completely down the set of promotional steps and may not fall over the side, stop partway or leave the promotional roll area. No one may touch the die until the roll is complete.
