HAPPY HOUR RULES

SLOT HOT SEAT

- 1. Player must have B Connected Card inserted correctly into any video poker, video reel, video keno and/or slot machines and be actively playing during IOAM-2PM or 4PM-9PM, December 26-30, 2011. To be considered actively playing, a bet must be made at least every 30 seconds.
- 2. It is the player's responsibility to ensure that their card is properly inserted in the machine.
- 3. On an average of 15 minutes from 10AM to 2PM and 4PM to 9PM a randomly generated slot machine will be picked and the guest playing on that machine will win cash.
- 4. \$125 Cash will be awarded to the 10AM-2PM winners and \$150 Cash will be awarded to the 4PM-9PM winners.
- 5. The guest winning the Cash must match the name on the B Connected Card inserted into the machine at the time the prize is won. Guest must present photo ID to redeem the Cash.
- 6. There will be a total of 16 winners per 10AM-1:45PM session, 20 winners per 4PM-8:45PM session and a total of 180 winners for the promotion period.
- 7. Promotion period is defined as 10AM-1:45PM and 4PM-8:45PM, December 26, 2011 to December 30, 2011.

DOUBLE ROYALS

- 1. Beginning Monday, December 26, 2011 and ending Friday, December 30, 2011, any player that hits two Royal Flushes (no wild cards, maximum bet and B Connected Card properly inserted in the machine) between 10AM and 9PM will receive a double payout.
- 2. Players will receive a Double Jackpot Form for their first Royal Flush, no wild cards. In order to receive the double payout, players must present this form to the Slot Attendant after hitting their second qualifying royal flush. Valid photo identification and B Connected Card must accompany the Double Jackpot Form. Players will only receive an additional Double Jackpot Form if the player hits another Royal Flush, no wild cards, within the promotional period.
- 3. On Multi Video Poker Line Games, Triple Play, Five Play, Ten Play, Fifty Play and Spin Poker games, all Royal Flushes (no wild cards) must be on the primary hand (first line only) to qualify for the double payout.
- 4. One Double Royal Payout per player, per day. Maximum payout of \$5,000 on any bonus award regardless of denomination played. Double Royal payout will be the lesser of the two jackpots.
