



# SAIL AWAY WITH THE SUNCOAST

- All poker players with a BConnected card in a cash game are eligible for this promotion.
- Players will earn one (1) virtual drawing ticket at twenty (20) hours of live poker play.
- Players will earn hours in two (2) qualifying periods. The first period is January 12, 2012 to March 5, 2012. The second qualifying period is April 1, 2012 to June 1, 2012. Double hours for the Free-roll will not count towards this promotion.
- Players whose ticket is drawn will receive a voucher good for two for the Ante Up Poker Cruise sailing from Port Canaveral, FL. (\$844 value), August 27-31, 2012.
- Winning players will also receive up to \$1000 airfare reimbursement.
- In both March and June we will give away two (2) cruise packages each day on the days of the Suncoast Free-Roll tournament. The Poker Room will draw one winner's name one hour before the March and June Free-roll, and one winner's name one hour after the free-roll.

For every 17 players in the tournament, one (1) cruise package (cruise for two with \$1000 allowance for airfare) will be awarded. If there are not enough entrants (17 players) to award a cruise package, the prize money will be distributed according to the Poker Room Daily Tournament Prize Distribution.
