Royal Flush Rush Video Poker Promotion Rules

- Valid for Video Poker Players only
 - Effective date for promotion: **November 1- 30, 2009**
1. Beginning at 12:01 a.m. on Sunday, November 1, 2009, all B Connected cardholders playing Video Poker will be eligible when they hit a Natural Royal Flush on \$.25, \$.50, or \$1 Video Poker machine. The promotion will continue until 11:59 p.m. on Monday, November 30, 2009.
 2. To qualify, the B Connected cardholder must play max bet on the machine. Additionally, it is the B Connected cardholder's responsibility to properly insert his/her card into the slot machine's card reader and to verify acceptance of the card.
 3. The winning Royal Flush must be a "natural" Royal Flush (i.e. no wild cards contained in the combination).
 4. When a cardholder wins a Royal Flush on a \$.25 Video Poker machine, they will win \$250 in Slot dollars.
 5. When a cardholder wins a Royal Flush on a \$.50 Video Poker machine, they will win \$375 in Slot dollars.
 6. When a cardholder wins a Royal Flush on a \$1 Video Poker machine, they will win \$500 in Slot dollars.
 7. The Slot Dollar award will be doubled on sequential and reversible Royal Flushes. For example, the \$.25 award would be \$250 X 2=\$500, etc.
 8. Only the person who wins the Royal Flush will be eligible for the Slot Dollars.
 9. The Slot dollars will be added to the cardholders account by a Sam's Town representative.
 10. Sam's Town Tunica is not responsible for machine malfunctions. It the cardholders responsibility to contact a slot employee to report any malfunctions on the machine.
 11. All winners are responsible for all applicable local, state and federal taxes.
 12. Sam's Town Tunica is not responsible for misplaced, lost or stolen B Connected cards.
 13. Cardholder must be 21 years of age or older and a customer in good standing with Sam's Town Tunica in order to participate.
 14. Valid only at Sam's Town Tunica, Robinsonville, MS.
 15. Employees of Sam's Town Hotel & Gambling Hall are not eligible to participate in promotions.
 16. The Mississippi Gaming Commission reserves the right to investigate any and all complaints and disputes regarding tournaments, promotions and drawings. Such disputes and complaints will be resolved in accordance with the Mississippi Gaming Control Act and the Mississippi Gaming Commission Regulations.
 17. Management reserves the right to cancel, change or modify the tournament, promotion or drawing with prior notification to the Mississippi Gaming Commission, but must do so at least three (3) days prior to the commencement of the activity.
