

Young At Heart After Dark Rules

1. The **Promotion** is valid at the following four (4) participating properties: The Orleans, Gold Coast, Suncoast and Sam's Town every Wednesday beginning June 3, 2015 through December 30, 2015 from 7:00 p.m. to 11:59 p.m.
2. Participants must be B Connected members and must be at least fifty (50) years of age. B Connected membership is free and available at the B Connected Club.
3. Participants may earn a Mystery Point Multiplier (up to fifty (50) times points) each Wednesday from 7:00 p.m. to 11:59 p.m. during the **Promotion** at any of the four (4) participating properties. Participants must swipe at the kiosk after 7:00 p.m. prior to play in order to activate the point multiplier. After swiping, base points earned between 7:00 p.m. and 11:59 p.m. will be eligible for the multiplier.
4. After earning two hundred (200) base slot points between 7:00 p.m. and 11:59 p.m., participant may swipe at the kiosk to receive a \$10 dining credit voucher valid on the Wednesday the points are earned at any of the four (4) participating properties owned restaurants or T.G.I. Friday's. The voucher must be redeemed by midnight.
5. Slot points do not include point multipliers, bonus points, or point transfers. It is the player's responsibility to make sure his or her valid B Connected card is properly inserted in the machine to earn slot points.
6. Base points exceeding 10,000 points per day on Video Poker at The Orleans, Gold Coast and Sam's Town are not available for promotional point multipliers. Base points exceeding 25,000 points per day on Video Poker and Reels at Suncoast are not available for promotional point multipliers. Excluded machines will be marked to indicate that it is not valid for promotional multipliers.
