Young At Heart Rules

- 1. The *Promotion* is valid at the following three (3) participating properties: Main Street Station, California and Fremont every Wednesday beginning February 7, 2018 through December 26, 2018.
- 2. Participants must be B Connected members and must be at least fifty (50) years of age. B Connected membership is free and available at the B Connected Club.
- 3. Participants may swipe at any promotional kiosk from 7:00am each Wednesday to redeem the following free offers;
 - A Mystery Point Multiplier (up to fifty (50) times points on Reels and up to ten (10) times points on Video Poker) each Wednesday from 7:00 a.m. to 11:59 p.m. during the *Promotion* at any of the three (3) participating properties. Participants must swipe at the kiosk prior to play in order to activate the point multiplier.
 - One (1) Free Drawing entry for the \$500 Drawing that Wednesday, must be redeemed before 4:30pm. Will not be valid for any other drawing
- 4. After earning twenty (20) base slot points, participant may swipe at the kiosk and choose one of the free prizes available for selection. All prizes are valid and must be redeemed on the day they are printed and at the property they are printed unless otherwise indicated. Participants account will not be debited for any points earned.
- 5. Slot points do not include point multipliers, bonus points, or point transfers. It is the player's responsibility to make sure his or her valid B Connected card is properly inserted in the machine to earn slot points.
