## **Young At Heart Rules**

- 1. The *Promotion* is valid at the following three (3) participating properties: Main Street Station, California and Fremont every Wednesday beginning February 7, 2018 through December 26, 2018.
- 2. Participants must be B Connected members and must be at least fifty (50) years of age. B Connected membership is free and available at the B Connected Club.
- 3. Participants may swipe at any promotional kiosk from 7:00am each Wednesday to redeem the following free offers:
  - A Mystery Point Multiplier (up to fifty (50) times points on Reels and up to ten (10) times points on Video Poker) each Wednesday from 7:00 a.m. to 11:59 p.m. during the *Promotion* at any of the three (3) participating properties. Participants must swipe at the kiosk prior to play to activate the point multiplier.
  - One (1) Free Drawing entry for the \$500 Drawing that Wednesday, must be redeemed before 4:30pm. Will not be valid for any other drawing
- 4. After earning twenty (20) base slot points, participant may swipe at the kiosk and choose one of the free prizes available for selection. All prizes are valid and must be redeemed on the day they are printed and at the property they are printed unless otherwise indicated. Participants account will not be debited for any points earned.
- 5. Slot points do not include point multipliers, bonus points, or point transfers. It is the player's responsibility to make sure his or her valid B Connected card is properly inserted in the machine to earn slot points.
- 6. Promotional points are capped at 100,000 points per day on Video Poker and Reels at each property. Excluded machines will be marked to indicate that it is not valid for promotional multipliers.
- 7. Virtual *Drawings* will be held on Wednesdays at 5:00 p.m.
  - a. Fremont drawings will be held at the Players Club
  - b. California drawings to be held at the Player's Club
  - c. Main Street Station drawings to be held at the end of the Blackjack Pit.
- 8. Beginning at 7:00 a.m., participants must swipe their B Connected card at the kiosk to claim their one (1) free drawing entry into that day's Young At Heart *Drawing*. Once the one (1) free drawing entry is claimed, the participant can then earn additional entries into that day's Young At Heart *Drawing*. Earning periods are from Wednesday to Wednesday during the promotional period, beginning with the first Wednesday of each month.
  - a. Slot machine players receive one (1) virtual entry for every twenty-five (25) base points.
  - b. Table games will earn one (1) entry for every one (1) hour of rated play with a minimum average bet of \$5.
- 9. It is the player's responsibility to make sure their valid B Connected card is properly inserted in the machine and to request that their table game play be rated.
- 10. All drawing entries are "virtual" and must be activated (electronically deposited into the cyber drawing drum) at a kiosk at the property where entries are earned. Participants must activate their entries beginning at 12:00 p.m. until 4:45 p.m. each Wednesday. Wednesday entries earned after 4:45 p.m. will not be eligible for any drawing.
- 11. There is a maximum of 10,000 entries per day per account for each drawing.
- 12. Participants win in the *Drawing* if their B Connected account number is drawn. Five (5) accounts will be drawn in each of the drawings. Each winner will receive \$100 slot dollars each. A person may only be selected to be a participant once per drawing.
- 13. Participants must be present to win and have three (3) minutes to identify themselves to drawing personnel once their account or name has been called. Valid identification and B Connected card is required for all prize winners. Valid identification is defined as a current valid form of one of the following: state issued driver's license with picture, state issued identification card with picture, military identification card with picture, or government issued passport. If winner is not a U.S citizen, a current valid passport or alien registration card is required. After the three (3) minutes have expired, those participants not present will forfeit their chance of any prize money and the next name will be drawn.
- 14. All virtual entries are removed from the virtual drawing drum after the drawing each Wednesday.

- 16. No substitution or transfer of prizes by winners permitted.

- 18. Additional entries may be awarded through other marketing programs such as, but not limited to, Direct Mail, Email, Text, or B Connected Online.
- 19. No substitution or transfer of prizes by winners permitted.
- 20. Boyd reserves the right to determined that anyone who is deemed in the sole and absolute discretion of the Boyd management to be an "advantage player," to be ineligible to participate in the *Promotion or Drawing*, or to have his/her ability to participate in the *Promotion or Drawing* otherwise limited.
