Young At Heart Rules

- 1. The *Promotion* is valid at the following four (4) participating properties: The Orleans, Gold Coast, Suncoast, and Sam's Town every Wednesday beginning February 7, 2018 through December 26, 2018.
- 2. Participants must be B Connected members and must be at least fifty (50) years of age. B Connected membership is free and available at the B Connected Club.
- 3. Participants may swipe at any promotional kiosk from 7:00am each Wednesday to redeem the following free offers;

- 15. All drawing entries from the month's previous weekly Young at Heart Drawings each Wednesday will be eligible for the Sunday Young at Heart Funday Young at Heart Drawing each month.
- 16. Beginning at 7:00 a.m. on the last Sunday of each month, participants must swipe their B Connected card at the kiosk to claim their one (1) free drawing entry into that day's Sunday Young at Heart Funday *Drawing*. Once the one (1) free drawing entry is claimed, the participant can then earn additional entries into that day's *Drawing*.
 - a. Slot machine players receive one (1) virtual entry for every twenty-five (25) base points.
 - b. Table games will earn one (1) entry for every one (1) hour of rated play with a minimum average bet of \$5.
- 17. It is the player's responsibility to make sure their valid B Connected card is properly inserted in the machine and to request that their table game play be rated.
- 18. All drawing entries are "virtual" and must be activated (electronically deposited into the cyber drawing drum) at a kiosk at the property where entries are earned. Participants must activate their entries beginning at 12:00 p.m. until 5:45 p.m. each Sunday. Activated entries will be valid for each drawing hour from 2:00pm to 6:00pm if activated at least 15 minutes prior to that hour's drawing. Entries activated less than 15 minutes before the next drawing will be valid for the next available drawing. Entries earned or activated after 5:45 p.m. will not be eligible for any drawing.

Valid identification is defined as a current valid form of one of the following: state issued driver's license with picture, state issued identification card with picture, military identification card with picture, or government issued passport. If winner is not a U.S citizen, a current valid passport or alien registration card is required.
