## Young At Heart Rules

- 1. The *Promotion* is valid at the following three (3) participating properties: Main Street Station, California and Fremont every Wednesday beginning September 19, 2018 through December 26, 2018.
- 2. Participants must be B Connected members and must be at least fifty (50) years of age. B Connected membership is free and available at the B Connected Club.
- 3. Participants may swipe at any promotional kiosk from 7:00am each Wednesday to redeem the following free offers;
  - A Bonus Point Multiplier of 11 times points on Reels and Video Poker for Sapphire tier members and above each Wednesday from 7:00 a.m. to 11:59 p.m. during the *Promotion* at any of the three (3) participating properties. Participants that are Sapphire tier members and above only, must swipe at the kiosk prior to play to activate the point multiplier.
  - One (1) Free Drawing entry for the \$500 Drawing that Wednesday, must be redeemed before 4:45pm. Will not be valid for any other drawing
- 4. After earning one (1) tier credit, participant may swipe at the kiosk and randomly win one of the prizes available. All prizes are valid and must be redeemed on the day they are printed and at the property they are printed unless otherwise indicated. Participants account will not be debited for any points earned.
- 5. Tier credits do not include B Connected points, point multipliers, bonus points, or point transfers. It is the player's responsibility to make sure his or her valid B Connected card is properly inserted in the machine to earn slot points.
- 6. Excluded machines will be marked to indicate that it is not valid for promotional multipliers.
- 7. Virtual *Drawings* will be held on Wednesdays at 5:00 p.m.
