## 2019 B Connected New Member Bonus Rules

- 1. The *Promotion* is valid at the following eight (8) participating properties: Aliante, The Orleans, Gold Coast, Suncoast, Sam's Town, California, Fremont and Main Street Station beginning July 1, 2019 through September 30, 2019.
- 2. Promotion is available to new Ruby B Connected accounts that have been established during the promotion period. B Connected membership is free and available at the B Connected Club. Must be 21 years of age or older
- 3.
