Young At Heart Rules

- 1. The *Promotion* is valid at the following three (3) participating properties: Main Street Station, California and Fremont every Wednesday beginning January 2, 2019 through December 25, 2019.
- 2. Participants must be B Connected members and must be at least fifty (50) years of age. B Connected membership is free and available at the B Connected Club.
- 3. Participants may swipe at any promotional kiosk from 7:00am each Wednesday to redeem the following free offers;
 - A Bonus Point Multiplier of 11 times points on Reels and Video Poker for Sapphire tier members and above each Wednesday from 7:00 a.m. to 11:59 p.m. during the *Promotion* at any of the three (3) participating properties. Participants that are Sapphire tier members and above only, must swipe at the kiosk prior to play to activate the point multiplier.

- 4. After earning one (1) tier credit, participant may swipe at the kiosk and randomly win one of the prizes available.
