# 2020 Love to Win Rules

#### THURSDAY & SUNDAY KIOSK SWIPE & WIN PROMOTION

- 1. The *Promotion* is valid at the following seven (7) participating properties: Aliante, The Orleans, Gold Coast, Suncoast, Sam's Town, Cannery, and Eastside Cannery.
- 2. Participants must be player club members. Player club membership is free and available at the players club. Must be 21 years of age or more to be a member.
- 3. At Aliante, The Orleans, Gold Coast, Sam's Town and Suncoast, every Thursday and Sunday from February 6 27, 2020, participants who have earned ten (10) Tier Credits from 8:00 a.m. through 10:00 p.m. may swipe at the kiosk to receive a prize voucher. Participants must swipe for their prize by 9:59 p.m. on the day the Tier Credits were earned at the property where they were earned.
- 4. At **Cannery and Eastside Cannery**, every Thursday and Sunday from February 6 27, 2020, participants who have earned one hundred (100) same day base points or ten (10) Table points from 8:00 a.m. through 10:00 p.m. may swipe at the kiosk to receive a prize voucher. Participants must swipe for their prize by 9:59 p.m. on the day the base points were earned at the property where they were earned.
- 5. Maximum one (1) Kiosk Swipe & Win per Thursday and Sunday. Participants who received a FREE Kiosk Swipe & Win are not eligible to earn at any location for the Thursday and Sunday Kiosk Swipe & Win promotion.
- 6. Select participants may receive an additional Invite Only Kiosk Swipe & Win.
- 7. All printed vouchers will include date and time issued and redemption instructions, details and exclusions. Each voucher must be redeemed within the stated time frame from issue, at the property it was earned, or the offer will be forfeited.
- 8. Prizes include: Up to 1 Million Points, B REWARD\$ (slot play), Dining Credits and more.

## **CASH DRAWINGS**

- 9. The *Cash Drawing* will be held every Friday and Saturday, February 7 29, 2020, at 6:15 p.m. for Gold Coast, Suncoast, Sam's Town, Cannery and Eastside Cannery, and at 7:15 p.m. for Aliante and The Orleans.
- 10. Participants may earn entries into the virtual *Drawing* at any of the seven (7) participating properties beginning at 3:00 a.m. February 2, 2020 and ending February 29, 2020 at 6:00 p.m. for Gold Coast, Suncoast, Sam's Town, Cannery and Eastside Cannery, and at 7:00 p.m. for Aliante and The Orleans.
- 11. At Aliante, The Orleans, Gold Coast, Sam's Town and Suncoast, slot and table games players receive one (1) virtual entry for every one (1) Tier Credit earned.
- 12. At **Cannery and Eastside Cannery**, slot machine players receive one (1) virtual entry for every ten (10) base slot points or one (1) Table Point earned each day.

16. All drawing entries are "virtual" and must be activated (electronically deposited into our virtual drawing drum) at a casino promotional kiosk at the property where entries are earned. 17. Aliante, The Orleans, Gold Coast, Sam's Town, Suncoast, Cannery, and Eastside Cannery will each hold one (1) drawing on Friday and one (1) drawing on Saturday (see times on rule#9), where five (5) winners will be selected in each drawing. Drawing and winner check-in will take place at the following locations:

- 18. There is a maximum of 10,000 entries, per day, per person, for the drawing.
- 19. Participants must be present at the property, during the drawing time to win and have three (3) minutes to identify themselves once their name has been called. If winner is not in the immediate drawing area, they may identify themselves at the alternate check-in area determined by each property (see rule# 17) within 3 minutes. Verified winners must report immediately to the drawing area to participate in the drawing. If winner causes a delay of the promotion of more than 2 minutes, that winner will be considered not present and a new winner will be drawn. After the three (3) minutes have expired, a new name will be drawn until five (5) claimed winners have been identified. Valid identification and Player card are required for all prize winners. The prize money will be awarded to the winner that was drawn and not the substitute. Prizes include: \$3,000, \$1,000, \$750, \$500, \$500 or re-spin, \$400 and \$250. If participant lands on the \$500 or re-spin they must decide if they will take the \$500 and no additional spin or they forfeit the \$500 and re-spin, the prize landed on the second spin is the final prize.

- 21. Select participating properties may offer their winners the option for a 10% increase in prize value if taken as B REWARD\$.
- 22. All activated virtual entries are removed from the virtual drawing drum after the weekly cash drawing each Saturday.

### FINAL DRAWINGS

- 23. The *Final Drawing* will be held on Saturday, February 29, 2020 at 8:15 p.m. where five (5) winners at each participating property will be selected.
- 24. All accumulated earned entries from February 2 29, 2020 will be available for activation on the *Final Drawing* on February 29, 2020.
- 25. Participants may receive 29X bonus entries on Saturday, February 29, 2020.
- 26. All drawing entries are "virtual" and must be activated (electronically deposited into our virtual drawing drum) at a casino promotional kiosk at the property where entries are earned. 27. In the order drawn, each winner will be given a chance to spin the Love to Win Wheel to determine his or her initial prize amount. The same Prize Wheel procedure in rule#19 applies for the Final Drawing. Once all five (5) winners have their initial prize amounts, in the same order drawn, each winner will select one (1) sealed Prize Multiplier envelope out of five (5) sealed envelopes. The sealed envelopes contain 2X, 3X, 4X, 5X and 10X Prize Multiplier, which will multiply each winner's initial prize amount with the multiplier listed inside their chosen envelope.

#### **Celebration Spins**

- 28. The *Celebration Spin* will be held at participating properties every Friday and Saturday, February 7-28, 2020 at 8:15 p.m. and on Saturday, February 29, 2020 it will be held at 9:15 p.m.
- 29. At Aliante, The Orleans, Gold Coast, Sam's Town and Suncoast, Celebration Spins are open to participants who have earned five (5) Tier Credits from 3:00 a.m. to 8:00 p.m. on each Friday and each Saturday. Participants must have swiped at any kiosk after earning the qualifying tier credits then select one (1) of six (6) colors before 8:00 p.m. On February 29, 2020, ending time will be extended until 9:00 p.m.
- 30. At **Cannery and Eastside Cannery**, Celebration Spins are open to participants who have earned fifty (50) base points or five (5) Table points from 3:00 a.m. to 8:00 p.m. on each Friday and each Saturday. Participants must have swiped at any kiosk after earning the qualifying base points then select one (1) of six (6) colors before 8:00 p.m. On February 29, 2020, ending time will be extended until 9:00 p.m.
- 31. Aliante, The Orleans, Gold Coast, Sam's Town, Suncoast, Cannery, and Eastside Cannery will each hold one (1) Celebration Spin on Friday and one (1) Celebration Spin on Saturday at the following locations: Aliante: Adjacent to ETA lounge The Orleans: B Connected Club Gold Coast: B Connected Club

Sam's Town: B Connected Club Suncoast: Promotion area adjacent to the Race and Sports Cannery: Players Club, located near the Parking Garage Elevators Eastside Cannery: Casino floor, near Promotions Center

- 32. A representative will spin a wheel with the six (6) colors that participants had an opportunity to select from. Whatever color the wheel lands on will be the winning color for that day's Celebration Spin. Each participant who selected that color earlier that day at the kiosk will share equally in a prize pool of a minimum \$2,500 B REWARD\$.
