MAY 2018 Amazing May Promotion Rules

FRIDAY KIOSK PROMOTION

- 1. The *Promotion* is valid at the following four (4) participating properties: The Orleans, Gold Coast, Suncoast, Sam's Town.
- 2. Participants must be B Connected members. B Connected membership is free and available at the B Connected Club. Must be 21 years of age or more to be a B Connected member.
- 3. On the following Fridays in May 4, 11, 18 & 25, 2018, participants who have earned ten (10) base points on slots or video poker from 10:00 a.m. through 10:00 p.m. may swipe at the kiosk to receive a prize voucher. Participants must swipe for their prize by 9:59pm on the day the base points were earned at the property where they were earned. Participants account will not be debited for points earned.
- 4. Prize vouchers will include various prizes including a Free Entry to that week's Bonus Winner Drawing for a chance to participate in that week's Saturday cash drawing, Slot Dollars®, dining credits, and more.
- 5. Slot points do not include point multipliers, bonus points, or point transfers. It is the player's responsibility to make sure his or her valid B Connected card is properly inserted in the machine to earn slot points.
- 6. All printed vouchers will include, date and time issued and redemption instructions, details and exclusions. Each voucher must be redeemed within the stated time frame from issue, at the property it was earned, or the offer will be forfeited.

CASH DRAWINGS

- 7. Weekly virtual *Drawings* will be held at participating properties on Saturdays, May 5, 12, 19 & 26, 2018.
- 8. Participants may earn entries into the Virtual Drawing at any of the four (4) participating properties beginning at 3:00 a.m. April 28, 2018 and ending May 26, 2018 at 6:00 pm for Orleans and Sam's Town, and at 8:00 p.m. for Gold Coast and Suncoast. Drawing entry earning periods are from Saturday to Saturday during the promotional period.
- 9. Slot machine players receive one (1) virtual entry for every ten (10) base points earned each day with their B Connected card properly inserted in their machines. Does not include point multipliers, bonus points or point transfers. It is the player's responsibility to make sure their card is properly inserted in the machine.
- 10. Table games players will earn one (1) entry for every one (1) hour of rated play with a minimum average bet of \$5 and earn one (1) additional entry for each additional \$5 average bet. It is the player's responsibility to request that their play be rated.
- 11. On Fridays, May 4,11, 18 & 25, 2018 from 10:00am 10:00pm, participants who earn 10 base slot points and swipe at a kiosk may win a prize voucher for one (1) free entry into that week's Bonus Winner Drawing. Each participating property will have a drawing drum located at the B Connected club. Participants may deposit their voucher into the drawing drum by 10:30pm on the Friday it is earned.
- 12. On Fridays, May 4, 11, 18 & 25, 2018, at 11:00pm, each participating property will draw one (1) Bonus Winner for a guaranteed spot in the following day's cash drawing. The winner will be notified via email and the winner's name will be posted at the B Connected club. Winners will have until 12:00pm, the following day, (Saturday) to claim the prize of the right to participate in that Saturday cash drawing. If the winner does not claim the prize, the prize will be forfeited and the participant will not be allowed to participate as a winner in the Saturday drawing. There will be no other winners selected in the Bonus Winner drawing.
- 13. Participants may receive 2X bonus drawing entries on Thursdays, May 3, 10, 17 & 24, 2018.
- 14. Additional electronic entries may be given as prize through direct mail, e-mail, online or via text message, as well as property-specific entry multiplier days.

- 15. All drawing entries are "virtual" and must be activated (electronically deposited into our cyber drawing drum) at a casino promotional kiosk at the property where entries are earned. Participants must activate their entries at any kiosk at least fifteen (15) minutes prior to the drawing time on the day of the drawing. Entries earned during the fifteen (15) minute period prior to the drawing will not be eligible for activation in that pending drawing. Participants may activate their entries beginning at 12:00pm, at the properties where the drawing entries are earned on drawing days.
- 16. **The Orleans, Gold Coast, Suncoast and Sam's Town** will each hold one (1) drawing on each Saturday, where ten (10) winners will be selected in each drawing. If there is a Bonus Winner from the Friday Kiosk promotion; that winner will be in addition to the ten (10) selected winners. Drawing and the cash envelope selections will take place at the following locations and times:

The Orleans: South end of the Race & Sports Book, 6:15 p.m.

Gold Coast: West end of the casino adjacent to Cornerstone, 8:15 p.m.

Sam's Town: The drawing area on the 2nd floor near Bingo, 6:15 p.m.

Suncoast: Race and Sports Lounge at 8:15 p.m.

- 17. All activated virtual entries are removed from the virtual drawing drum after the final drawing each Saturday at Orleans, Gold Coast, Suncoast and Sam's Town.
- 18. There is a maximum of 10,000 entries, per day, per person, for the drawing.
- 19. Participants must be present to win and have three (3) minutes to identify themselves once their name has been called. Bonus Winners from the Kiosk Promotion must redeem the voucher, per the instructions printed on the voucher to be included as a winner in the drawing. Valid identification and B Connected card is required for all prize winners. Valid identification is defined as a current valid form of one of the following: state issued driver's license with picture, state issued identification card with picture, military identification card with picture, or government issued passport. If winner is not a U.S citizen, a current valid passport or alien registration card is required. After the three (3) minutes have expired, a new name will be drawn until a winner has been identified.
- 20. In the order their name was drawn, beginning with the Bonus Winner from the Friday Kiosk Promotion, (if applicable); each of the winners will be allowed to select one (1) sealed cash envelope from the drawing board. The Bonus Winner or the first winner drawn will go first in each drawing, and will select one (1) of thirty (30) sealed envelopes on display, the next person, (either first or second drawn) will select from the remaining twenty-nine (29) sealed envelopes, the next person drawn will select from the twenty-eight (28) sealed envelopes and so on until all winners have selected an envelope.
- 21. The cash envelopes will contain prize amounts ranging from \$250 to \$5,000 cash. Additional bonus draws may also be represented in an envelope. In this case, the participant will keep the cash prize already selected, and they will be entitled to a bonus draw. The participant will keep both cash prizes.
- 22. A person may only be selected to be a winner once per drawing day. No substitution or transfer of prize by winners permitted.
- 23. Winners are responsible for any and all taxes and other fees. Winners with cumulative winnings of \$600 or more will receive a 1099 tax form.
- 24. Boyd may disqualify any person for any prize based upon fraud, dishonesty, violation of promotional rules or other misconduct, whether or not related to this Drawing.
- 25. Boyd reserves the sole and absolute discretion to determine if a player is an "advantage player," and therefore ineligible to participate in the *Promotion or Drawing*, or to have his/her ability to participate in the *Promotion or Drawing* otherwise limited. - 26. Individuals who have entered any government agency self-exclusion program, or have been otherwise excluded from casinos by a government agency or Boyd Gaming or one of its affiliates are not eligible to participate.

- 27. Anyone activating *Promotion or Drawing* entries for any account other than their own may, at the discretion of Boyd, be excluded from the *Promotion or Drawing* at issue or permanently excluded from all Boyd *Promotions or Drawings*. Boyd reserves the right, in its sole discretion without notice, to cancel, terminate, modify, or suspend the *Promotion or Drawing*.
- 30. Any attempt by any person to deliberately damage or manipulate any program or equipment to undermine the legitimate operation of this *Promotion or Drawing* may be a violation of criminal and civil laws and, should such an attempt be made, Boyd reserves the right to seek recourse against any such person to the fullest extent of the law.
- 31. Entries will be retained for record-keeping purposes in accordance with company policy and legal requirements.
- 32. Any dispute or situation not covered by these rules shall be resolved by the property's management in a manner that is fair to all parties.  - (B) Filed only in the state or federal courts situated in Clark County, Nevada state, and each participant hereby consents and submits to the personal jurisdiction of such courts for the purposes of litigating any such disputes, claims or causes of action; any and all claims, judgments and awards shall be limited to actual out-of-pocket costs incurred, but in no event attorneys' fees; and under no circumstances will entrants be permitted to obtain awards for third parties, and each participant hereby waives all rights to claim punitive, exemplary, incidental, special, consequential damages and any other damages, other than for actual out-of-pocket expenses, and any and all rights to have damages multiplied or otherwise increased.
- 33. By participating in the *Promotion or Drawing*, each winner gives Boyd Gaming permission to take photographs of each winner and use his or her name and/or likeness for advertising and publicity purposes for no compensation.
