FRIDAY & SATURDAY PULL TAB PROMOTION

- 1. The **Promotion** is valid at the following properties; Aliante and Suncoast.
- 2. Participants must be player club members. Player club membership is free and available at the players club. Must be 21 years of age or more to be a member.
- 3. At **Aliante and Suncoast**, every Friday, Saturday from August 2–31, 2019, participants who have earned one (1) Tier Credit from 8:00a.m. through 10:00pm. may swipe at the kiosk to receive an Electronic Pull Tab. Participants must swipe for their prize by 9:59 p.m. on the day the Tier Credit was earned at the property where it was earned.
- 4. Maximum one (1) Electronic Pull Tab per Friday and Saturday. Participants who received a FREE Pull Tab Mailer or Free Electronic Pull Tab are not eligible to earn at any location for the Friday and Saturday Electronic Pull Tab promotion.
- 5. Some Electronic Pull tab prizes will be on a printed voucher. All printed vouchers will include date and time issued and redemption instructions, details and exclusions. Each voucher must be redeemed within the stated time frame from issue, at the property it was earned, or the offer will be forfeited.
- 6. Invited guest mailed Pull Tabs are non-transferable and non-negotiable. Pull tabs not revealed at the designated area in front of an authorized Team Member will not be honored. Must present Players Club Card, valid photo ID to redeem pull tab. Not responsible for lost or tampered pull tabs, NO replacements will be given out.

CASH DRAWINGS

- 8. The *Drawing* will be held at Aliante and Suncoast on Saturday, August 31, 2019.
- 9. Participants may earn entries into the virtual *Drawing* at participating properties beginning at 3:00 a.m. August 1, 2019 and ending at 8:00pm on August 31, 2019.
- 10. At **Aliante and Suncoast**, slot and table games players receive one (1) virtual entry for everyone (1) Tier Credit earned.
- 11. At **Aliante and Suncoast**, participants may receive additional free entries August 1, 2019 beginning at 3:01am through August 31, 2019 at 8:00pm for each day during the promotional period based on their card level status. Participants must swipe their cards daily to receive entry or entries.
 - Ruby members receive one (1) entry daily
 - Sapphire members receive two (2) entries daily
 - Emerald, Onyx and Titanium members receive three (3) entries daily
- 12. Participants may earn 5 Times drawing entries every Friday & Saturday during the promotion period.
- 13. There is a maximum of 10,000 entries, per day, per person, for the drawing.
- 14. Tier Credit and slot points do not include spendable points, point multipliers, bonus points, or point transfers. It is the player's responsibility to make sure his or her valid player card is properly inserted in the machine and to request that their table game play be rated.
- 15. Additional electronic entries may be given as prizes through direct mail, e-mail, online or via text message, as well as property-specific entry multiplier days.
- 16. All drawing entries are "virtual" and must be activated (electronically deposited into our virtual drawing drum) at a casino promotional kiosk at the property where entries are earned.
