Golden Wheel Bingo Rules

April 2019

- The Golden Wheel Consolation Promotion will be held at Suncoast and Aliante Bingo Rooms on Mondays, April 8, 15, 22, and 29, 2019. While the Golden Wheel Consolation Promotion is valid on the B Connected Big Bucks game at all sessions, there will be only one (1) Golden wheel spin per week.
- 2. Participants must be at least 21 years old and a B Connected member. B Connected membership is free and available at the Players Club.
- 3. Bingo players must purchase a minimum of one blue pack to play the session.
- 4. Players must purchase a minimum of one B Connected Big Bucks 3on strips to be eligible for this promotion.
- 5. If a Bingo was not achieved on 48-54 numbers, a B Connected Big Bucks consolation wheel will go into play.
- 6. The eligible participant/(s) that bingos after 54 numbers will be the consolation winner/(s), The player or designated Bingo official, if more than one winner, will pull a ball from the bag that contains only white balls and one gold ball. If a white ball is drawn the player will spin the regular consolation wheel, if a gold ball is drawn the player will spin the golden consolation wheel.
- Once the gold ball is drawn, the Golden Consolation wheel is out of play for the remainder of sessions.
- 8. At Aliante each week The Golden Wheel drawing bag will consist of 6 white balls and 1 gold ball, one ball for each session.
- At Suncoast each week The Golden Wheel drawing bag will consist of 7 white balls and 1 gold ball, one ball for each session.
- 10. If the consolation wheel is not spun at any session, one (1) white ball will be removed from the bag so the remaining number of balls is equal to the remaining number of sessions left for the promotion day.
- 11. In the event of multi-winners, the supervisor will draw a ball from the bag, once a ball is drawn the caller will proceed to spin the wheel. If gold ball is drawn, the golden wheel is in play, if the white ball is drawn the regular consolation wheel will be in play. All payouts are aggregate.
- 12. In the event Gold ball has not been drawn by 10:00pm session at Aliante or 11:00pm session at Suncoast, these sessions will automatically have a Golden wheel consolation spin, regardless if we have a winner on numbers 48-54 play will continue for the consolation spin on the Golden wheel.
- Each consolation wheel has prize values displayed and whatever the wheel spin lands on as the indicated prize will be the prize paid.
- 14. Management reserves all rights.
- Winners are responsible for any and all taxes and other fees. Winners with cumulative winnings of \$1,200 or more will receive a W-2 tax form.
- Boyd may disqualify any person for any prize based upon fraud, dishonesty, violation
 of promotional rules or other misconduct, whether or not related to this Promotion.
- 17. Boyd reserves the sole and absolute discretion to determine if a player is an "advantage player," and therefore ineligible to participate in the Promotion, or to have his/her ability to participate in the Promotion otherwise limited. Any such "advantage player" who is already a player club member prior to the commencement of the Promotion may be notified by Boyd prior to the commencement of the Promotion of any such ineligibility or limitation determination. Otherwise, any such "advantage player" will be notified by Boyd of any ineligibility or limitation determination as soon as possible after such determination is made. An "advantage player" is described as a skilled or knowledgeable player who will find legal ways to gain mathematical advantages while gambling.
- 18. Individuals who have entered any government agency self-exclusion program, or have been otherwise excluded from casinos by a government agency or Boyd Gaming or one of its affiliates are not eligible to participate.
- Anyone activating Promotion or Drawing entries for any account other than their own may, at the discretion of Boyd, be excluded from the Promotion at issue or

- permanently excluded from all Boyd Promotions or Drawings. - Entries will be retained for record-keeping purposes in accordance with company policy and legal requirements.
- 24. Any dispute or situation not covered by these rules shall be resolved by the property's management in a manner that is fair to all parties. Participants in this Promotion also hereby agree that all issues and questions concerning these Official Rules and the Promotion shall be governed by Nevada law without giving effect to any principles of conflicts of law of any jurisdiction. Disputes, claims and causes of action at law or in equity arising out of or relating to this Promotion or any prize awarded may be subject to the Dispute Resolution provisions of the Nevada Gaming Control Act and may be resolved pursuant to a regulatory decision set forth in NRS 463.361 et seq. Any and all disputes, claims and causes of action at law or in equity arising out of or relating to this Promotion or any prize awarded that are not subject to the Dispute Resolution provisions of the Nevada Gaming Control Act and not resolved pursuant to a regulatory decision set forth in NRS 463. 361 et seq., shall be:
 - A) Resolved individually, without resort to any form of class action; and
 - (B) Filed only in the state or federal courts situated in Clark County, Nevada state, and each participant hereby consents and submits to the personal jurisdiction of such courts for the purposes of litigating any such disputes, claims or causes of action; any and all claims, judgments and awards shall be limited to actual out-of-pocket costsincurred, but in no event attorneys' fees; and under no circumstances will entrants be permitted to obtain awards for third parties, and each participant hereby waives all rights to claim punitive, exemplary, incidental, special, consequential damages and any other damages, other than for actual out-of-pocket expenses, and any and all rights to have damages multiplied or otherwise increased.
- 25. By participating in the Promotion, each winner gives Boyd Gaming permission to take photographs of each winner and use his or her name and/or likeness for advertising and publicity purposes for no compensation. As a condition of the redemption of any prize in this Promotion, each winner further agrees to execute an affidavit of eligibility, a publicity release and a liability release, in the form provided by Boyd Gaming.
- 26. Employees of Gaming Arts and Fortunet are not eligible to participate in this promotion. Employees of Boyd Gaming are eligible to participate in this promotion but may not play at their own property.
