2019 Freedom To Roam Rules

FRIDAY, SATURDAY, SUNDAY KIOSK SWIPE & WIN PROMOTION

- 1. The *Promotion* is valid at the following seven (7) participating properties: Aliante, The Orleans, Gold Coast, Suncoast, Sam's Town, Cannery, and Eastside Cannery.
- 2. Participants must be player club members. Player club membership is free and available at the players club. Must be 21 years of age or more to be a member.
- 3. At **Aliante, The Orleans, Gold Coast, Sam's Town and Suncoast**, every Friday, Saturday, and Sunday in July 2019, participants who have earned one (1) Tier Credit from 8:00 a.m. through 10:00 p.m. may swipe at the kiosk to receive a prize voucher. Participants must swipe for their prize by 9:59 p.m. on the day the Tier Credit was earned at the property where it was earned.
- 4. At Cannery and Eastside Cannery, every Friday, Saturday, and Sunday in July 2019, participants who have earned ten (10) same day base points or one (1) Table points from 8:00 a.m. through 10:00 p.m. may swipe at the kiosk to receive a prize voucher. Participants must swipe for their prize by 9:59 p.m. on the day the base points were earned at the property where they were earned.
- 5. Maximum one (1) Kiosk Swipe & Win per Friday, Saturday and Sunday. Participants who received a FREE Kiosk Swipe & Win are not eligible to earn at any location for the Friday, Saturday and Sunday Kiosk Swipe & Win promotion.
- 6. All printed vouchers will include date and time issued and redemption instructions, details and exclusions. Each voucher must be redeemed within the stated time frame from issue, at the property it was earned, or the offer will be forfeited.
- 7. Prizes include: Slot Dollars, Dining Credits, and More.

DRAWINGS

- 8. The *Cash Drawing* will be held at Aliante, The Orleans, Gold Coast, Suncoast, Sam's Town, Cannery and Eastside Cannery every Friday and Saturday in July 2019 at 6:15 p.m. and the *Final Drawing* for the Jeep Giveaway will be held on Saturday, July 27, 2019 at 6:15 p.m.
- 9. Participants may earn entries into the virtual *Drawing* at any of the seven (7) participating properties beginning at 3:00 a.m. June 30, 2019 and ending July 27, 2019 at 6:00 p.m.
- 10. At **Aliante, The Orleans, Gold Coast, Sam's Town and Suncoast**, slot and table games players receive one (1) virtual entry for every one (1) Tier Credit earned.
- 11. At Cannery and Eastside Cannery, slot machine players receive one (1) virtual entry for every ten (10) base slot points or one (1) Table Point earned each day.
- 12. At **Aliante, The Orleans, Gold Coast, Sam's Town and Suncoast**, participants may receive additional free entries June 30 beginning at 3:01am through July 26 at 6:00pm for each day during the promotional period based on their card level status. - 13. At Cannery and Eastside Cannery, participants may receive additional entries June 30 beginning at 3:01am through July 26 at 6:00pm for each day of play during the promotional period based on their card level status. Participants must swipe their cards daily to receive entry or entries.
 - CAN Club members receive one (1) entry daily
 - Frequent Flyer members receive two (2) entries daily
 - High Flyer and First Class members receive three (3) entries daily
- 14. Tier Credit and slot points do not include spendable points, point multipliers, bonus points, or point transfers. It is the player's responsibility to make sure his or her valid player card is properly inserted in the machine and to request that their table game play be rated.
- 15. Additional electronic entries may be given as prizes through direct mail, e-mail, online or via text message, as well as property-specific entry multiplier days.
- 16. All drawing entries are "virtual" and must be activated (electronically deposited into our virtual drawing drum) at a casino promotional kiosk at the property where entries are earned. Entries earned during the fifteen (15) minute period prior to the drawing will not be eligible for activation in that pending drawing.

Aliante, The Orleans, Gold Coast, Sam's Town, Suncoast, Cannery, and Eastside Cannery will each hold one (1) drawing on Friday at 6:15 p.m. and one (1) drawing on Saturday at 6:15 p.m., where five (5) winners will be selected in each drawing. - 19. There is a maximum of 10,000 entries, per day, per person, for the drawing.
- 20. Participants must be present to win and have three (3) minutes to identify themselves once their name has been called. Valid identification and Player card is required for all prize winners. Valid identification is defined as a current valid form of one of the following: state issued driver's license with picture, state issued identification card with picture, military identification card with picture, or government issued passport. If winner is not a U.S citizen, a current valid passport or alien registration card is required. After the three (3) minutes have expired, a new name will be drawn until five (5) claimed winners have been identified.
- 21. For the first seven (7) drawings at each property, in the order drawn, each winner will be given a chance to spin the Freedom to Roam Wheel to determine his or her prize. The Prize Wheel will be reset at the \$200 prize that is located before the \$1,000 prize for each spin and must make at least one complete revolution. The winner may designate one substitute to spin the wheel on their behalf if the winner is unable to make the wheel make at least one complete revolution, substitute must be at least 21 years of age or older. The prize money will be awarded to the winner that was drawn and not the substitute. Prizes include: \$1,000, \$750, \$500, \$400, \$300, \$300 or re-spin, \$250 and \$200. If participant lands on the \$300 or re-spin they must decide if they will take the \$300 and no additional spin or they forfeit the \$300 and re-spin, the prize landed on the second spin, is the final prize.
- 22. Select participating properties may offer their winners the option for a 10% increase in prize value if taken as Slot Dollars.
- 23. All activated virtual entries are removed from the virtual drawing drum after the final drawing each Saturday.
- 24. All accumulated earned entries from June 30 July 27, 2019 will be available for activation on the *Final Jeep Drawing* on July 27, 2019.
- 25. For the *Final Drawing* on Saturday, July 27, 2019, five (5) winners at each participating property will be selected.
- 26. In the order drawn, each winner will select one (1) sealed envelope out of five (5) sealed envelopes. - 31. The *Celebration Spin* will be held at participating properties every Friday and Saturday in July 2019 at 8:15 p.m.
- 32. At **Aliante, The Orleans, Gold Coast, Sam's Town and Suncoast**, Celebration Spins are open to participants who have earned five (5) Tier Credits from 3:00 a.m. to 8:00 p.m. on each Friday and each Saturday. Participants must have swiped at any kiosk after earning the qualifying tier credits then select one (1) of six (6) colors before 8:00 p.m.
- 33. At Cannery and Eastside Cannery, Celebration Spins are open to participants who have earned fifty (50) base points or five (5) Table points from 3:00 a.m. to 8:00 p.m. on each Friday and each Saturday. Participants must have swiped at any kiosk after earning the qualifying base points then select one (1) of six (6) colors before 8:00 p.m.
- 34. Aliante, The Orleans, Gold Coast, Sam's Town, Suncoast, Cannery, and Eastside Cannery will each hold one (1) Celebration Spin on Friday at 8:15 p.m. and one (1) Celebration Spin on Saturday at 8:15 p.m. at the following locations:

Aliante: Adjacent to ETA lounge The Orleans: B Connected Club Gold Coast: B Connected Club Sam's Town: B Connected Club

Suncoast: Promotion area adjacent to the Race and Sports

Cannery: Players Club, located near the Parking Garage Elevators

Eastside Cannery: Casino floor, near Promotions Center

- 35. A representative will spin a wheel with the six (6) colors that participants had an opportunity to select from. Whatever color the wheel lands on will be the winning color for that day's Celebration Spin. Each participant who selected that color earlier that day at the kiosk will share equally in a prize pool of a minimum \$2,500 Slot Dollars. The shared value of the prize pool shall not be less than \$5 Slot Dollars per person. Winners will have the Slot Dollar prize automatically added to their Players Club account within one (1) hour of the conclusion of the Celebration Spin.  - (B) Filed only in the state or federal courts situated in Clark County, Nevada state, and each participant hereby consents and submits to the personal jurisdiction of such courts for the purposes of litigating any such disputes, claims or causes of action; any and all claims, judgments and awards shall be limited to actual out-of-pocket costs incurred, but in no event attorneys' fees; and under no circumstances will entrants be permitted to obtain awards for third parties, and each participant hereby waives all rights to claim punitive, exemplary, incidental, special, consequential damages and any other damages, other than for actual out-of-pocket expenses, and any and all rights to have damages multiplied or otherwise increased.
- 48. By participating in the *Promotion or Drawing*, each winner gives Boyd Gaming permission to take photographs of each winner and use his or her name and/or likeness for advertising and publicity purposes for no compensation.
