2019 Pumpkin Patch Pick Rules

FRIDAY, SATURDAY, SUNDAY KIOSK SWIPE & WIN PROMOTION

- 1. The *Promotion* is valid at the following seven (7) participating properties: Aliante, The Orleans, Gold Coast, Suncoast, Sam's Town, Cannery, and Eastside Cannery.
- 2. Participants must be player club members. Player club membership is free and available at the players club. Must be 21 years of age or more to be a member.
- 3. At Aliante, The Orleans, Gold Coast, Sam's Town and Suncoast, every Friday, Saturday, and Sunday in October 2019, participants who have earned ten (10) Tier Credit from 8:00 a.m. through 10:00 p.m. may swipe at the kiosk to receive a prize voucher. Participants must swipe for their prize by 9:59 p.m. on the day the Tier Credit was earned at the property where it was earned.
- 4. At **Cannery and Eastside Cannery**, every Friday, Saturday, and Sunday in October 2019, participants who have earned one hundred (100) same day base points or ten (10) Table points from 8:00 a.m. through 10:00 p.m. may swipe at the kiosk to receive a prize voucher. Participants must swipe for their prize by 9:59 p.m. on the day the base points were earned at the property where they were earned.
- 5. Maximum one (1) Kiosk Swipe & Win per Friday, Saturday and Sunday. Participants who received a FREE Kiosk Swipe & Win are not eligible to earn at any location for the Friday, Saturday and Sunday Kiosk Swipe & Win promotion.

CASH DRAWINGS

- 17. There is a maximum of 10,000 entries, per day, per person, for the drawing.
- 18. Participants must be present at the property, during the drawing time to win and have three (3) minutes to identify themselves once their name has been called. If winner is not in the immediate drawing area, they may identify themselves at the alternate check-in area determined by each property (see rule# 16) within 3 minutes. Verified winners must report immediately to the drawing area to participate in the drawing. If winner causes a delay of the promotion of more than 2 minutes, that winner will be considered not present and a new winner will be drawn. - 23. The *Final Camaro Drawing* will be held on Saturday, October 26, 2019 at 8:15 p.m. where five (5) winners at each participating property will be selected.
- 24. All accumulated earned entries from September 29 October 26, 2019 will be available for activation on the *Final Camaro Drawing* on October 26, 2019.
- 25. All drawing entries are "virtual" and must be activated (electronically deposited into our virtual drawing drum) at a casino promotional kiosk at the property where entries are earned. Participants may activate their entries beginning at 12:00 p.m. on October 26, 2019 at Aliante, The Orleans, Gold Coast, Suncoast and Sam's Town. Participants must activate their entries at any kiosk at least fifteen (15) minutes prior to the drawing time on the day of the drawing. Entries earned during the fifteen (15) minute period prior to the drawing will not be eligible for activation in that pending drawing.
- 26. At Cannery and Eastside Cannery participants may activate their entries beginning at 6:00 p.m. on October 26, 2019. All drawing entries are "virtual" and must be activated (electronically deposited into our virtual drawing drum) at a casino promotional kiosk at the property where entries are earned or by inserting the participants CAN Club Card at any machine and earning one (1) point between 6:00pm and 7:59pm. Participants must activate their entries at least fifteen (15) minutes prior to the drawing time on the day of the drawing. Entries earned during the fifteen (15) minute period prior to the drawing will not be eligible for activation in that pending drawing.
- 27. In the order drawn, each winner will select one (1) sealed envelope out of five (5) sealed envelopes. One (1) sealed envelope contains the 2020 Camaro (or \$24,000 B REWARD\$ or \$22,000 Cash option where available), and the

At Aliante, The Orleans, Gold Coast, Sam's Town and Suncoast, Celebration Spins are open to participants who have earned five (5) Tier Credits from 3:00 a.m. to 8:00 p.m. on each Friday and each Saturday. Participants must have swiped at any kiosk after earning the qualifying tier credits then select one (1) of six (6) colors before 8:00 p.m. On October 26, 2019, ending time will be extended until 9:00 p.m.
- 34. At **Cannery and Eastside Cannery**, Celebration Spins are open to participants who have earned fifty (50) base points or five (5) Table points from 3:00 a.m. to 8:00 p.m. on each Friday and each Saturday. Participants must have swiped at any kiosk after earning the qualifying base points then select one (1) of six (6) colors before 8:00 p.m. On October 26, 2019, ending time will be extended until 9:00 p.m.
- 35. Aliante, The Orleans, Gold Coast, Sam's Town, Suncoast, Cannery, and Eastside Cannery will each hold one (1) Celebration Spin on Friday and one (1) Celebration Spin on Saturday at the following locations:

Aliante: Adjacent to ETA lounge The Orleans: B Connected Club Gold Coast: B Connected Club Sam's Town: B Connected Club Suncoast: Promotion area adjacent to the Race and Sports Cannery: Players Club, located near the Parking Garage Elevators Eastside Cannery: Casino floor, near Promotions Center

- 36. A representative will spin a wheel with the six (6) colors that participants had an opportunity to select from. Whatever color the wheel lands on will be the winning color for that day's Celebration Spin. Each participant who selected that color earlier that day at the kiosk will share equally in a prize pool of a minimum \$2,500 B REWARD\$. The shared value of the prize pool shall not be less than \$5 B REWARD\$ per person.
