

## YOUNG AT HEART RULES

1. The **Promotion** is valid at the following six (6) participating properties: **Aliante, The Orleans, Gold Coast, Suncoast, Sam's Town, and Cannery** every Tuesday beginning October 6, 2020 through December 29, 2020.
2. Participants must be B Connected members and must be at least fifty (50) years of age. Participants must be a B Connected member two days prior to the start of the promotion. Membership is free and available at the B Connected Club.
3. Participants may swipe at any promotional kiosk from 7:00 a.m. each Tuesday to redeem the following free offers, where available.
  - One (1) Free Bingo Blue Pack, valid on the day the voucher is printed at Gold Coast, Suncoast, Cannery and Sam's Town only.
  - At **Aliante, The Orleans, Gold Coast, Sam's Town, Suncoast and Cannery**, bonus Point Multiplier of ten (10X) times points on Reels and Video Poker for Sapphire Tier B Connected members and above each Tuesday from 7:00 a.m. to 11:59 p.m. during the **Promotion** at any of the six (6) participating properties. 16. Individuals who have entered any self-limited or government agency self-exclusion program or have been otherwise excluded from casinos by a government agency or Boyd Gaming or one of its affiliates are not eligible to participate.
