

\$500,000 Pumpkin Patch Pick
September 30, 2012 – November 17, 2012

1. The \$500,000 Pumpkin Patch Pick contains two elements in which participants may win a share of more than \$500,000 in cash and prizes.
 - a. Collect and Win with Instant Prizes (*Promotion*)
 - b. Drawings (*Drawing*)
2. The *Promotion* and *Drawing* are valid at the following four (4) participating properties: The Orleans, Gold Coast, Suncoast and Sam's Town from September 30, 2012 through November 17, 2012.
3. Participants must be B Connected members. B Connected membership is free and available at the B Connected Club. Must be 21 years of ages or more to be a B Connected member.

Promotion

4. Participants win playing the *Promotion* by collecting matching sets of game pieces on the *Promotion* game board or by winning instant prizes. The *Promotion* game board is available at the B Connected club.
5. The *Promotion* may be played each Friday and Saturday from September 30 through November 17, 2012.

- f. \$50 Cash - Complete the Bowling set which contains one game piece each of:
 - The Orleans Bowling
 - Gold Coast Bowling
 - Suncoast Bowling
 - Sam's Town Bowling
 10. In addition, Instant Winner prizes will include 1,000,000 Bonus Points, dinner for two at select restaurants, \$50 Cash, Hotel Stays, Slot Dollars, Gift Cards, Buffets, Salon or Spa discounts, Movie Tickets, Free Bowling and other prizes.
 11. After playing the game at the kiosk, winning participants will receive a ticket from the kiosk. Tickets will contain details on the prize, as well as the redemption information for the prize.

Drawing

12. Virtual **Drawings** will be held on Saturdays October 6, 13, 20 & 27 and November 3, 10 and 17, 2012 at 8:15 p.m.
 - a. Suncoast drawings will be held adjacent to the High Limit Area
 - b. The Orleans drawings will be held at the South end of the Race & Sports Book
 - c. Gold Coast drawings will be held in the West end of the Casino between the buffet and Cortez Room
 - d. Sam's Town drawings will be held on the 2nd floor in Tourney Town near Bingo
13. Participants may earn entries into the Virtual **Drawing** at any of the four (4) participating properties beginning at 8:00 a.m. September 30 and ending November 17 at 8:00 p.m.;
 - a. Slot machine players receive one (1) virtual entry for every fifty (50) base points

18. All drawing entries are "virtual" and must be activated (electronically deposited into the cyber drawing drum) at a kiosk at the property where entries are earned. Participants must activate their entries beginning at Noon each Saturday until 8:00 p.m. each Saturday Entries earned after 8:00 p.m. each Saturday will not be eligible for that night's drawing but are eligible for the next available drawing.
