

## HOW TO PLAY SWIPE \& WIN

1. Promotion takes place daily, beginning Sunday, February 25, 2018 and ending Saturday, March 31, 2018
2. Participants Swipe C.A.N. Card at any CAN Club Kiosk to obtain Drawing Entries or Instant Win prizes.
3. Participants may earn up to three (3) swipes per day by earning five (5) same day base points for the first swipe, and one hundred fifty (150) same day base points each for the second and third swipe on their C.A.N. Card.
4. Instant Win Prizes: If the Kiosk reveals a Prize identified in these Official Rules as an Instant Win Prize, then the participant named on the Kiosk Voucher is the winner of that Prize
RULES
5. Participants must be 21 years of age or older and must be a CAN Club member. Persons without a CAN Club Card can sign up for a free card at the Players' Club.
6. Drawing Entries and Instant Win Prizes will be awarded through the CAN Club Kiosks at random
7. "Instant Win" Prizes are subject to verification at Eastside Cannery Casino. All prizes are subject to verification at the CAN Club. Prizes are null and void and will be rejected if not obtained through authorized, legitimate channels. If any part of any prize is counterfeited, or if any prize is altered or traded, or if any part of any prize is illegible, mutilated, eaten, damaged or tampered with in any way, or if any prize contains or reflects printing, typographical, mechanical or other errors or omissions, the prize will be rejected and will be deemed void and invalid. Each Player acknowledges and agrees that the decisions of Eastside Cannery Casino and the CAN Club shall be conclusive in matters relating to the Game, including, without limitation, determinations regarding the validity, entries, attempted entries, and prizes submitted for verification. HOW TO PLAY CASH DRAWINGS
11. Drawings will be held at 7:00pm every Friday \& Saturday, March 2-31, 2018, located on the Casino floor, at the Promotions Center.
12. Players can begin earning kiosk drawing entries from 3:00am on Sunday, February 25, 2018 until Saturday, March 31, 2018 at 6:59pm.
13. One (1) kiosk drawing entry for every one hundred (100) same day base points earned.
14. 10X Drawing Entries every Monday \& Wednesday.
15. Kiosk drawing entries will be awarded to the player's account automatically. Check entries at any CAN Club Kiosk.
16. Players must check-in to activate kiosk drawing entries by either swiping their CAN Card at any CAN Club Kiosk or inserting their CAN Card at any machine and playing between $6: 00 \mathrm{pm}$ and $6: 59 \mathrm{pm}$ to be eligible for the $7: 00 \mathrm{pm}$ drawing. It is the participant's responsibility to verify their entries have been properly activated at the CAN Club Kiosk or Players' Club prior to the end of the final Check-in time of 6:59pm each drawing day
17. At each drawing twenty-five (25) entries are selected via computer. Five (5) Winners per drawing will get a

23. Winners will be announced over the Casino PA System. Once a winner has been called they will have three (3) minutes to claim their prize at the drawing area, located on the casino floor, at the Promotions Center or be verified as the winner by an Eastside Cannery employee (in which case, the verifying employee must contact the drawing staff before the three (3) minutes expires and the verified winner must immediately make their way to the drawing area to claim their prize). ## CASH DRAWING RULES

26. No purchase necessary
27. Participants must be 21 years of age or older and must be a CAN Club member. Persons without a CAN Club Card can sign up for a free card at the Players' Club.
28. All cash winners must show their CAN Card, valid ID and Social Security\# to be verified. If proper identification cannot be provided, the winner forfeits the prize and another winner will be drawn.
29. Each verified Winner hereby agrees, grants and releases the right, but not the obligation, to use his/her name, voice, and likeness, along with his/her address and any statements made by or attributed to such Winner in any and all media now known or hereafter devised, in perpetuity and throughout the universe for advertising and promotional purposes in connection with the Game and other promotions without further notice, review approval or compensation, and releases all directors, officers, employees, agents, advertising and promotion agencies, representatives, and service agencies from any liability with respect thereto.

MISCELLANEOUS

In the event the Boyd Gaming Corporation is impeded or prevented from continuing with the Game as planned or intended by any event beyond its control, including, but not limited to fire, flood, natural or manmade epidemic or health hazard or crisis, earthquake, explosion, labor dispute or strike, act of God or public enemy, satellite or equipment failure, riot or civil disturbance, terrorist threat or activity, war (declared or undeclared), any federal, Provincial, or local government law, order, or regulation public health crisis, the order of any court or jurisdiction, or by any other cause not reasonably within the Boyd Gaming Corporation control, the Boyd Gaming Corporation shall have the right to modify, suspend, extend or terminate the Game.
