OFFICIAL RULES

1. Participants must be at least 21 years of age and be a member of our Prime Rewards Club. Prime Rewards membership is free and available at the Casino Cage. Please see Casino Cage for all applicable Prime Rewards Club rules.
2. All Prime Rewards members playing slot machines, video poker and/or video keno are eligible to participate.
3. One winner will be chosen every hour between 6:30pm-10:30pm every Saturday. The dates are October 5, 12, 19 & 26, 2019.
4. Slot machine players receive one (1) virtual entry for every fifteen (15) base points earned with their Prime Rewards card properly inserted in their machines. Base points do not include point multipliers, bonus points or point transfers. It is the player's responsibility to make sure their card is properly inserted in the machine.
