2019 Spin into Cash Rules

CASH DRAWINGS

- 1. The *Drawing* will be held at the Gold Coast every ever Saturday, June 1, 8, 15, 22, & 29 at 6:15 p.m. and The Orleans every Sunday, June 2, 9, 16, 23, & 30 at 6:15pm
- 2. Participants may earn entries into the virtual *Drawing* at the Gold Coast beginning at 3:01 am and The Orleans beginning at 2:01 am. May 26, 2019 and ending on June 29 at 6:00pm at the Gold Coast and June 30, 2019 at 6:00 pm at the Orleans.
- 3. At **Gold Coast and The Orleans**, slot and table games players receive one (1) virtual entry for every one (1) Tier Credit earned.
- 4. At **Gold Coast and The Orleans**, participants may receive additional free entries May 26 at Gold Coast beginning at 3:01 am and The Orleans beginning at 2:01 am through June 30 at 6:00pm for each day during the promotional period based on their card level status. Participants must swipe their cards daily to receive entry or entries.
 - Ruby members receive one (1) entry daily
 - Sapphire members receive two (2) entries daily
 - Emerald, Onyx and Titanium members receive three (3) entries daily
- 5. Tier Credit and slot points do not include spendable points, point multipliers, bonus points, or point transfers. It is the player's responsibility to make sure his or her valid player card is properly inserted in the machine and to request that their table game play be rated.
- 6. Additional electronic entries may be given as prizes through direct mail, e-mail, online or via text message, as well as property-specific entry multiplier days.
- 7. All drawing entries are "virtual" and must be activated (electronically deposited into our virtual drawing drum) at a casino promotional kiosk at the property where entries are earned. Participants may activate their entries beginning at 12:00 p.m. on drawing dates at Gold Coast and The Orleans. Participants must activate their entries at any kiosk at least fifteen (15) minutes prior to the drawing time on the day of the drawing. Entries earned during the fifteen (15) minute period prior to the drawing will not be eligible for activation in that pending drawing.
- 8. **Gold Coast and The Orleans** will each hold one (1) drawing where five (5) winners will be selected in each drawing. Drawing will take place at the following locations:

- 9. There is a maximum of 10,000 entries, per day, per person, for the drawing.
- 10. Participants must be present to win and have three (3) minutes to identify themselves once their name has been called. Valid identification and Player card is required for all prize winners. Valid identification is defined as a current valid form of one of the following: state issued driver's license with picture, state issued identification card with picture, military identification card with picture, or government issued passport. If winner is not a U.S citizen, a current valid passport or alien registration card is required. After the three (3) minutes have expired, a new name will be drawn until five (5) claimed winners have been identified.
- 11. In the order drawn, each winner will be given a chance to spin the Spin into Cash Wheel to determine his or her prize. The Prize Wheel will be reset at the \$250 prize that is located before the \$5,000 prize for each spin and must make at least one complete revolution. The winner may designate one substitute to spin the wheel on their behalf if the winner is unable to make the wheel make at least one complete revolution, substitute must be at least 21 years of age or older. The prize money will be awarded to the winner that was drawn and not the substitute. Prizes include: \$5,000, \$1,000, \$750, \$500, \$500 or re-spin and \$250. If participant lands on the \$500 or re-spin they must decide if they will take the \$500 and no additional spin or they forfeit the \$500 and re-spin, the prize landed on the second spin, is the final prize. If participant lands on \$500 Re-spin, participant keeps the \$500 and gets to spin the wheel one more time. Only one (1) Re-spin is allowed. Participant will keep the \$500 plus the amount landed on the Re-spin.

Celebration Spins

12. The Celebration Spins will be held at Gold Coast every Saturday, June 1, 8, 15, 22, & 29 and The Orleans every Sunday, June 2, 9, 16, 23, & 30 at 8:15 pm.

- 13. At **Gold Coast and The Orleans**, Celebration Spins are open to participants who have earned five (5) Tier Credits from 3:01am at Gold Coast and 2:01am at the Orleans to 7:45 pm on each Drawing Day. Participants must have swiped at any kiosk after earning the qualifying tier credits then select one (1) of six (6) colors before 7:45 pm.
- 14. Gold Coast and The Orleans will each hold one (1) Celebration Spins at 8:15pm at the following locations:

Gold Coast: B Connected Club **The Orleans**: B Connected Club

- 15. A representative will spin a wheel with the six (6) colors that participants had an opportunity to select from. Whatever color the wheel lands on will be the winning color for that day's Celebration Spin. Each participant who selected that color earlier that day at the kiosk will share equally in a prize pool of a minimum \$2,500 Slot Dollars. The shared value of the prize pool shall not be less than \$5 Slot Dollars per person. Winners will have the Slot Dollar prize automatically added to their Players Club account within one (1) hour of the conclusion of the Celebration Spin. Slot Dollar prizes must be activated by downloading with your player card at any slot machine. Slot Dollar prizes will expire at 11:59pm the following day. Slot Dollar prizes are not transferable and cannot be returned or exchanged. Expired Slot Dollars will not be reissued. All Slot Dollars must be downloaded and bet at least once before cashing out.
