

**ORLEANS LAST CHANCE QUALIFIER**  
**FRIDAY FEBRUARY 16, 2018**  
**CONTEST SCORING AND RULES**

Top THREE receive an entry into the 2018 HPWS

IN ADDITION TO THE HORSE PLAYER WORLD SERIES ENTRIES, ANY PRIZE MONEY OVER 23 ENTRIES, WILL BE AWARDED BACK TO THE PLAYERS BASED ON THE VALID TOTAL ENTRIES.

**ONCE WE HAVE REACHED 23 ENTRIES, THE ADDITIONAL ENTRIES WILL MAKE UP THE PRIZE MONEY. WE THEN WILL PAY THE TOP THREE WINNERS IN ADDITION TO THE ORLEANS SPONSORED HORSE PLAYER WORLD SERIES ENTRIES.**

1. Contestants will make 15 individual \$20 win/place contest wagers (mythical wagers). All wagers must be \$20 win/place. Contest wagers may be made on more than one selection per race, but it may not be the same horse. Each \$20 win/place bet is a separate wager and will count as one of the fifteen wagers for the day. Entries and fields go as a single wagering interest. No quarter horse race wager will be accepted.
2. Fifteen races must be played at the players choosing from the list of eligible contest tracks and races that will be offered at Orleans during the tournament. In the event of a system failure / computer malfunction and or dispute: Contestants must keep track of the number of tournament plays (15 plays). Any contestant making more than the required number of plays may be disqualified. It is the contestant's responsibility to keep all tournament tickets until the completion of the tournament. Tournament officials may request to see your tournament tickets / selections at any time.
3. Contest officials will provide a list of eligible simulcast tracks and races at least one week prior to the contest. All tracks and times are subject to change up until the start of the tournament.
4. Scratches will be refunded (0 points) and must be re-bet. Any unused wagers at the end of the day will be 0 points and will not be credited, refunded or carried over. If a player has wagered on a race that is considered a non-race, that selection will be considered no action and returned to the player.
5. Contest points will be based on full track odds for the first \$20. The remainder of the wager will be credited at a maximum of 19-1 on the WIN 9-1 on the place. It is the contestant's responsibility to make sure that they swipe their B-connected card at the Self-Service race contest terminals before the start of the "Orleans last chance qualifier" contest/tournament to confirm that your name is correct and you are able to make contest/tournament wagers. Boyd Gaming or "Orleans" will not be responsible for entrants being shut out of a Contest/Tournament Play because they failed to check their Contest/Tournament account prior to the start of the first Contest/Tournament Track.
7. It is the contestant's responsibility to make sure that their contest ticket is accurate. Self-betting machines cannot void tickets if a ticket needs to be voided, you must go to the specified contest void window. No ticket will be changed or altered after the race is locked out. No points will be credited on a contest wager that has not been accepted into the computer system regardless of the circumstances.
8. It is the contestant's responsibility to make sure they press the finish button when they have completed making their selection(s) to clear the machine and exit from their account. If contestant(s) fails to do this another contestant will be able to place selections on your account. Boyd Gaming will not be responsible if this should happen. All completed plays will stand.
9. Pay-outs will be done after the last contest track is official barring any disputes.
10. In the event of a tie for any position, the prize money will be divided equally among the tied contestants. For example: If there is a two way tie for first place, the tied contestants will split first and second. If in the event of a tie for any of the entries awarded into the Horse Player World Series, The first tie breaker will be the player(s) with the most wins. second tie breaker will be the player(s) who signed up first. There will only be Three Entries given away to the 2018 Horse Player World Series.
12. Partners, Corporations, LTD's, INC's and LLC's are not allowed. Contestants are signed up and entered into the contest/tournament as an individual person and must provide proper identification and social security number/TIN number for required payouts.
14. Contestants must be at least 21 years of age.
15. All Boyd Gaming house rules apply to the contest unless otherwise stated.
16. All contestants grant permission to Boyd Gaming to use their name and photograph for publicity purposes.
17. Management reserves all rights, including the right to modify or cancel this contest, at its sole discretion, and at any time. In the event of a cancellation, all entry fees and deposits will be refunded.
18. Any dispute or situation not covered by these rules shall be resolved by the properties management, in a manner that is fair to all parties. If the patron is not satisfied with management's decision, he or she may exercise their rights under NRS 463.361 ET eq. and request the Nevada Gaming Control Board to review the matter.
19. The B Connected card is your tournament card.
