Young at Heart Rules

- 1. The *Promotion* is valid at the following six (6) participating properties: Aliante, The Orleans, Gold Coast, Suncoast, Sam's Town, and Eastside Cannery every Wednesday beginning January 2, 2019 through December 25, 2019.

- 7. Weekly Virtual *Drawings* will be held on Wednesdays at 4:30 p.m.

 - c. Gold Coast drawings will be held at West end of the casino adjacent to Cornerstone
