



RULES

MARCH 1 - APRIL 1, 2017

1. This promotion is valid at Suncoast Hotel & Casino from March 1, 2017- April 1, 2017.
2. Participants must be at least 21 years old and a valid B Connected card member. Membership into
3. Participants will each receive a Poker Tournament drawing card. Each tournament entry for that participant, will receive (1) one stamp on the drawing card. Participants will have from March 1-31, 2017 to collect stamps on the drawing card. Once the card is full, it will be deposited into the drawing drum and be eligible for the promotional drawing.
4. It is the players' responsibility to make sure their card is requested to be stamped with Tournament play.
5. The drawing for this promotion will take place on April 1, 2017 at 12:00pm in the Suncoast Poker Room. At the drawing time, a Poker Room Shift Manager will draw cards from the drum until (3) three winners have been identified. In order of names drawn, winners will win;
