



RULES

Football Squares Synopsis

Players earn squares for each Ace High Flush or better using at least one card in their hand or by cashing in a daily tournament! Quarters are worth \$50 each for select Pro Football games. Players must be playing in a cash game and considered an active player during the games to win. That's up to \$1,000 per week, all regular season long!!! Over \$16,000!!!!

1. This promotion is valid at the Suncoast Hotel & Casino Poker Room from September 7, 2017 through Sunday, December 31, 2017
2. Players must be 21 years of age or more with a valid B Connected card to be eligible to take part in this promotion.
3. Players will earn squares by playing in qualified games with a promotional drop.
4. Players earn one (1) square for each qualifying hand or better made using at least one card in their hand. Qualifying hands in Stud and Hold'em will be any Ace High Flush. Players will earn double squares when playing in 4/8 Texas Hold'em or any qualified No-Limit Texas Hold'em. Players may also earn double squares when playing between the hours of 11 P.M. and 9 A.M.
5. Each player who cashes in a daily cash tournament may also select one (1) square. Cashing is defined as winning any amount from the designated prize pool.
6. Players may place their name in one (1) square for each qualifying hand. Players may not transfer ownership of a square, or put someone else's name in a square they have earned.
7. There will be one board for select regular season NFL Monday Night, Thursday Night, Sunday Morning, Sunday Afternoon, and Sunday Night games.
8. Players will start earning squares on Saturday, September 2, 2017 at midnight for the first week, and at the completion of each week's game for the following week.
9. The first Sunday games will be on Sunday September 10, 2017, and will be select 10:00 AM PST, 1:25 PM PST, and 5:30 PM PST games. The game will be selected and posted on the board each subsequent week.
10. The first Monday Night game will be the 7:20 PM PST game on September 11, 2017.
11. The first Thursday night game will be September 7, 2017 at 5:30 PM PST.
12. In the event of multiple games played on a Monday or Thursday night, the later game will be used per the NFL schedule.
13. In the event the NFL changes the official schedule, the board for the Monday or Thursday night game will be associated with the new teams playing on the appropriate Monday or Thursday night game.
14. The games selected for the Sunday games will be the game with the greatest chance of being televised. Once the televised game starts, the squares will remain associated with that game, even in the event of the game no longer being televised.
15. A Shift Manager will select, at random, the numbers approximately 10 minutes before the games scheduled start time. Once the selection starts, players can no longer earn squares for that game.
16. At the end of each quarter, a supervisor will identify the single digit or second digit of a double-digit score. The intersection of the number for each team will establish the winning square.
17. The final score is the score at end of the fourth quarter score regardless of overtime.
18. The results of all quarters will be based off the official NFL scoring from the official NFL website.
19. All quarters will be worth at least fifty dollars (\$50).
20. If a player wins a quarter and is unable or ineligible to claim their winnings, then that amount will be returned to the promotional pool and rolled over to the following week.
21. Players must be an active player in a cash game to win their quarter. An active player is defined as a player who has taken a hand, and does not have a missed blind button (big or small blind). If a player is playing in a Stud (or non-blind game), an active player is defined as a player who is present and has either posted their ante in the current hand or posted their ante in the most recent hand completed (the player has not missed a hand).
22. In the event a game is cancelled before the completion of the first quarter for any reason, then all names on the board will roll over to the following week and the prize amount on the quarters will remain the same. If one full quarter has completed play and a game is cancelled for any reason, then any un-played quarters will roll over to the following week as if they were unpaid.
23. The promotion will end with the 1:25pm PT game on Sunday December 31, 2017.
24. The official board for all games is the Suncoast football squares sheet located at the Poker Room Podium. Any other board is for player reference only.
25. Winners are responsible for any and all taxes and other fees. Winners with cumulative winnings of \$600 or more will receive a 1099 tax form.
26. Boyd may disqualify any person for any prize based upon fraud, dishonesty, violation of promotional rules or other misconduct, whether or not related to this promotion.
27. Boyd reserves the sole and absolute discretion to determine if a player is an "advantage player," and therefore ineligible to participate in the Promotion, or to have his/her ability to participate in the Promotion otherwise limited. Any such "advantage player" who is already a B Connected member prior to the commencement of the Promotion may be notified by Boyd prior to the commencement of the Promotion of any such ineligibility or limitation determination. Otherwise, any such "advantage player" will be notified by Boyd of any ineligibility or limitation determination as

soon as possible after such determination is made. An "advantage player" is described as a skilled or knowledgeable player who will find legal ways to gain mathematical advantages while gambling.

28. Individuals who have entered any government agency self-exclusion program, or have been otherwise excluded from casinos by a government agency or Boyd Gaming or one of its affiliates are not eligible to participate.
29. Anyone participating in this Promotion for any account other than their own may, at the discretion of Boyd, be excluded from the Promotion at issue or permanently excluded from all Boyd Promotions. Further, the holder of the account participating in the Promotions that have been used by a party other than the account holder may, at the discretion of Boyd, also be excluded from the Promotion at issue or permanently excluded from all Boyd Promotions.

If, for any reason, the Promotion is not capable of running as planned, including infection by computer virus, bugs, tampering, unauthorized intervention, fraud, technical failures, or any other causes within or beyond the control of Boyd which corrupt or affect the administration, security, fairness, integrity, or proper conduct of this Promotion, Boyd reserves the right, in its sole discretion without notice, to cancel, terminate, modify, or suspend the Promotion.
32. Any attempt by any person to deliberately damage or manipulate any program or equipment to undermine the legitimate operation of this Promotion may be a violation of criminal and civil laws and, should such an attempt be made, Boyd reserves the right to seek recourse against any such person to the fullest extent of the law.
33. Any obtained player information will be retained for record-keeping purposes in accordance with company policy and legal requirements.
34. Any dispute or situation not covered by these rules shall be resolved by the property's management in a manner that is fair to all parties. Participants in this Promotion also hereby agree that all issues and questions concerning these Official Rules and the Promotion shall be governed by Nevada law without giving effect to any principles of conflicts of law of any jurisdiction. Disputes, claims and causes of action at law or in equity arising out of or relating to this Promotion or any prize awarded may be subject to the Dispute Resolution provisions of the Nevada Gaming Control Act and may be resolved pursuant to a regulatory decision set forth in NRS 463.361 et seq. Any and all disputes, claims and causes of action at law or in equity arising out of or relating to this Promotion or any prize awarded that are not subject to the Dispute Resolution provisions of the Nevada Gaming Control Act and not resolved pursuant to a regulatory decision set forth in NRS 463.361 et seq., shall be:

 - (B) Filed only in the state or federal courts situated in Clark County, Nevada state, and each participant hereby consents and submits to the personal jurisdiction of such courts for the purposes of litigating any such disputes, claims or causes of action; any and all claims, judgments and awards shall be limited to actual out-of-pocket costs incurred, but in no event attorneys' fees; and under no circumstances will entrants be permitted to obtain awards for third parties, and each participant hereby waives all rights to claim punitive, exemplary, incidental, special, consequential damages and any other damages, other than for actual out-of-pocket expenses, and any and all rights to have damages multiplied or otherwise increased.

By participating in the Promotion, each winner gives Boyd Gaming permission to take photographs of each winner and use his or her name and/or likeness for advertising and publicity purposes for no compensation. As a condition of the redemption of any prize in this Promotion, each winner further agrees to execute an affidavit of eligibility, a publicity release and a liability release, in the form provided by Boyd Gaming.
