



OFFICIAL RULES

1. The Promotion is valid at Suncoast Hotel & Casino March 3, 2018 through March 31, 2018.
2. Participants must be B Connected members. B Connected membership is free and available at the B Connected Club. Must be 21 years of age or more to be a B Connected member.
3. The Drawings will be held at Suncoast on the following Saturdays, March 3, 10, 17, 24 and 31, 2018.
4. Participants may earn entries into the virtual drawing beginning at 2:01 am Sunday, February 25, 2018 and ending March 31, 2018 at 8:00 pm.
5. Slot machine players receive one (1) virtual entry for every ten (10) base points earned each day with their B Connected card properly inserted in their machines. Does not include point multipliers, bonus points or point transfers. It is the player's responsibility to make sure their card is properly inserted in the machine.
6. Table games will earn one (1) entry for every one (1) hour of rated play with a minimum average bet of \$5 and earn one (1) additional entry for each additional \$5 average bet. It is the player's responsibility to request that their play be rated.
7. Participants may receive ten (10) times additional entries every Tuesday, March 6, 13, 20 & 27, 2018 and Thursday, March 1, 8, 15, 22 & 29, 2018.
8. Additional electronic entries may be given as prizes through direct mail, e-mail, online or via text message, as well as property-specific entry multiplier days.
9. All drawing entries are "virtual" and must be activated (electronically deposited into our cyber drawing drum) at a casino promotional kiosk. Participants must activate their entries at any kiosk at least fifteen (15) minutes prior to the drawing time on the day of the drawing. Entries earned during the fifteen (15) minute period prior to the drawing will not be eligible for activation in that pending drawing.
10. Suncoast will hold two (2) drawings every Saturday, where ten (10) winners will be selected in each drawing. Drawing will take place at Race and Sports Lounge at 6:15 pm and 8:15 p.m. Participants may activate their entries beginning at 12:00 pm on Saturdays during the promotional period.
11. All activated virtual entries are removed from the virtual drawing drum after the final drawing on each Saturday.
12. There is a maximum of 10,000 entries, per day, per person, for the drawing.
13. Participants must be present to win and have three (3) minutes to identify themselves once their name has been called. Winners must present a valid photo ID and B Connected card. After the three (3) minutes have expired, a new name will be drawn until a winner has been identified.
14. In the order their name was drawn, each of the ten (10) winners will be allowed to select one (1) sealed cash envelope from the drawing board. The first winner drawn will go first in each drawing and will select one (1) of seven (7) sealed envelopes on display in a row and reveal a cash prize. Each successive winner will select an envelope in the same manner until each of the 10 winners have selected an envelope.
15. The prize board will be re-set with sealed envelopes after each winner makes their selection in each drawing.
16. Each winner will be offered the option for a 10% increase in prize value if taken as Slot Dollars.
17. A person may only be selected once per drawing day. No substitution or transfer of prize by winners permitted.
18. A person may only be selected to be a winner once per drawing day. No substitution or transfer of prize by winners permitted.
19. Winners are responsible for any and all taxes and other fees. Winners with cumulative winnings of \$600 or more will receive a 1099 tax form.
20. Boyd may disqualify any person for any prize based upon fraud, dishonesty, violation of promotional rules or other misconduct, whether or not related to this Drawing.
21. Boyd reserves the sole and absolute discretion to determine if a player is an "advantage player," and therefore ineligible to participate in the Promotion or Drawing, or to have his/her ability to participate in the Promotion or Drawing otherwise limited. 27. Entries will be retained for record-keeping purposes in accordance with company policy and legal requirements.
28. Any dispute or situation not covered by these rules shall be resolved by the property's management in a manner that is fair to all parties. Participants in this Promotion or Drawing also hereby agree that all issues and questions concerning these Official Rules and the Promotion or Drawing shall be governed by Nevada law without giving effect to any principles of conflicts of law of any jurisdiction. Disputes, claims and causes of action at law or in equity arising out of or relating to this Promotion or Drawing or any prize awarded may be subject to the Dispute Resolution provisions of the Nevada Gaming Control Act and may be resolved pursuant to a regulatory decision set forth in NRS 463.361 et seq.  - (B) Filed only in the state or federal courts situated in Clark County, Nevada state, and each participant hereby consents and submits to the personal jurisdiction of such courts for the purposes of litigating any such disputes, claims or causes of action; any and all claims, judgments and awards shall be limited to actual out-of-pocket costs incurred, but in no event attorneys' fees; and under no circumstances will entrants be permitted to obtain awards for third parties, and each participant hereby waives all rights to claim punitive, exemplary, incidental, special, consequential damages and any other damages, other than for actual out-of-pocket expenses, and any and all rights to have damages multiplied or otherwise increased.

By participating in the Promotion or Drawing, each winner gives Boyd Gaming permission to take photographs of each winner and use his or her name and/or likeness for advertising and publicity purposes for no compensation.
