OFFICIAL RULES

1. This Drawing will be held at Suncoast Hotel & Casino on Fridays and Saturdays in April 6, 7, 13, 14, 20, 21, 27 & 28, 2018.
2. Participants may earn entries into the Virtual Drawing at Suncoast beginning at 2:01am April 1, 2018 and ending April 28, 2018 at 8:00pm.
3. Slot machine players receive one (1) virtual entry for every ten (10) base points earned each day with their B Connected card properly inserted in their machines. Does not include point multipliers, bonus points or point transfers. It is the player's responsibility to make sure their card is properly inserted in the machine.
4. Table games will earn one (1) entry for every one (1) hour of rated play with a minimum average bet of \$5 and earn one (1) additional entry for each additional \$5 average bet. It is the player's responsibility to request that their play be rated.
5. Participants may receive 10X bonus drawing entries on Thursdays, April 5, 12, 19 & 26, 2018.
6. Additional electronic entries may be given as prize through direct mail, e-mail, online or via text message, as well as property-specific entry multiplier days.
7. All drawing entries are "virtual" and must be activated (electronically deposited into our cyber drawing drum) at a casino promotional kiosk at the property where entries are earned. Participants must activate their entries at any kiosk at least fifteen (15) minutes prior to the drawing time on the day of the drawing. Entries earned during the fifteen (15) minute period prior to the drawing will not be eligible for activation in that pending drawing. 8. Suncoast will hold two (2) drawings on Fridays and two (2) drawings on Saturdays, at 6:15pm and 8:15pm, where ten (10) winners will be selected in each drawing. Drawing and prize envelope selections will take place at the Race and Sports Lounge.
9. Participants may activate their entries beginning at 12:00pm on drawing dates.
10. All activated virtual entries are removed from the virtual drawing drum after the final drawing each Saturday.
11. There is a maximum of 10,000 entries, per day, per person, for the drawing.
12. Participants must be present to win and have three (3) minutes to identify themselves once their name has been called. Valid identification and B Connected card is required for all prize winners. Valid identification is defined as a current valid form of one of the following: state issued driver's license with picture, state issued identification card with picture, military identification card with picture, or government issued passport. If winner is not a U.S citizen, a current valid passport or alien registration card is required. After the three (3) minutes have expired, a new name will be drawn until a winner has been identified.
13. In the order their name was drawn, each of the ten (10) winners will be allowed to select one (1) sealed prize envelope from the drawing board. The first winner drawn will go first in each drawing and will select one (1) of thirty (30) sealed envelopes on display, the second person drawn will select from the remaining twenty-nine (29) sealed envelopes, the third person drawn will select from the twenty-eight (28) sealed envelopes and so on until all ten (10) winners have selected an envelope.
14. Envelopes will contain prizes from \$100 Slot Dollars to \$1,000 Cash.
