## OFFICIAL RULES

1. The Drawing will be held at Suncoast Casino on Fridays and Saturdays in June 1, 2, 8, 9, 15, 16, 22, 23, 29 & 30, 2018.
2. Participants must be at least 21 years old and a valid B Connected member. B Connected membership is free and available at the B Connected Club.
3. Participants may earn entries into the Virtual Drawing at Suncoast beginning at 2:01am May 27, 2018 and ending June 30, 2018 at 8:00pm.
4. Slot machine players receive one (1) virtual entry for every ten (10) base points earned each day with their B Connected card properly inserted in their machines. Does not include point multipliers, bonus points or point transfers. It is the player's responsibility to make sure their card is properly inserted in the machine.
5. Table games will earn one (1) entry for every one (1) hour of rated play with a minimum average bet of \$5 and earn one (1) additional entry for each additional \$5 average bet. It is the player's responsibility to request that their play be rated.
6. Participants may receive 10X bonus drawing entries on Tuesdays and Thursdays, May 29 & 31, June 5, 7, 12, 14, 19, 21, 26 & 28, 2018.
7. Additional electronic entries may be given as prize through direct mail, e-mail, online or via text message, as well as property-specific entry multiplier days.
8. All drawing entries are "virtual" and must be activated (electronically deposited into our cyber drawing drum) at a casino promotional kiosk at the property where entries are earned. Participants must activate their entries at any kiosk at least fifteen (15) minutes prior to the drawing time on the day of the drawing. Entries earned during the fifteen (15) minute period prior to the drawing will not be eligible for activation in that pending drawing. See property times listed below to determine when entries become available for activation.
9. Suncoast will hold two (2) drawings on Friday and two (2) drawings on Saturday, where twenty-five (25) winners will be selected in each drawing. Drawing and the prize envelope selections will take place at the Race and Sports Lounge at 6:15pm and 8:15pm.
10. Participants may activate their entries beginning at 12:00pm on drawing dates.
11. All activated virtual entries are removed from the virtual drawing drum after the final drawing each Saturday.
12. There is a maximum of 10,000 entries, per day, per person, for the drawing.
13. Participants must be present to win and have three (3) minutes to identify themselves once their name has been called. Valid identification and B Connected card is required for all prize winners. Valid identification is defined as a current valid form of one of the following: state issued driver's license with picture, state issued identification card with picture, military identification card with picture, or government issued passport. If winner is not a U.S. citizen, a current valid passport or alien registration card is required. After the three (3) minutes have expired, the prize will be forfeited.
14. In the order their name was drawn, each of the twenty-five (25) winners will be allowed to select one (1) sealed prize envelope from the drum, in the order they were drawn.
15. Prizes for each drawing will be awarded as follows:
  - a) 1st Place \$1,000 Cash
  - b) 2nd Place \$500 Cash
  - c) 3rd & 4th Place \$250 Cash
  - d) 5th - 25th Place \$100 Slot Dollars
16. A person may only be selected to be a winner once per drawing day. No substitution or transfer of prize by winners permitted.
17. Winners are responsible for any and all taxes and other fees. Winners with cumulative winnings of \$600 or more will receive a 1099 tax form.

Participants in this Promotion or Drawing also hereby agree that all issues and questions concerning these Official Rules and the Promotion or Drawing shall be governed by Nevada law without giving effect to any principles of conflicts of law of any jurisdiction. Disputes, claims and causes of action at law or in equity arising out of or relating to this Promotion or Drawing or any prize awarded may be subject to the Dispute Resolution provisions of the Nevada Gaming Control Act and may be resolved pursuant to a regulatory decision set forth in NRS 463.361 et seq.
