



DFFIGIAL RULE5

- 1. This promotion is valid every Tuesday, August 7, 14, 21, 2018 at the Suncoast Hotel & Casino.
- 2. Participants must be B Connected members. B Connected membership is free and available at the B Connected Club. Must be 21 years of age or older to be a B Connected member.
- 3. Participants may earn entries Tuesday, August 7, 14, 21, 2018, by playing their favorite video poker, video reel, video keno and/or slot machines from 3:00am until 5:45pm. After earning fifty (50) base points on their B Connected card, members will receive one (1) entry into the slot tournament that day. For each additional fifty (50) base points earned the participant will receive one (1) additional entry. Maximum, two entries per participant.
- 4. Additional entries may be given through direct mail, e-mail, online or via text message, as well as by way of property-specific promotions. Those players who received a free entry, may earn one (1) additional entry by playing (50) base points.
- 5. Entry tickets will be available at the kiosk at 11:30pm on Slot Tournament Tuesdays through 5:50pm and are valid on the date issued.
- 6. The Tournament will be held in the tournament area in front of the movie theater. Tournament play is on a first come, first served basis. Participation in the tournament is subject to availability. Participants must register to play in the tournament by 5:50pm each Tuesday. Participants with multiple entries may play two (2) games, one after the other.
- 7. Tournament play will be held from 12:00pm to 6:00pm on promotional days. Participants will play as soon as a seat is available. Each session is three (3) minutes.

- 17. In the event of any disputes, the decision of the Suncoast's Tournament Director will be final.
- 18. These rules and/or this tournament may also be modified or canceled by management at any time in its sole discretion without prior notification.
- 19. In the event a tournament machine should malfunction during a session, the player must notify a tournament official immediately. If another tournament slot machine is available during that session, the affected player will be given the opportunity to play the session on that slot machine, or re-play. In the event of a power outage, entrants should remain at their machines.
- 20. Boyd reserves the sole and absolute discretion to determine if a player is an "advantage player" and are therefore ineligible to participate in the Promotion or to have his/her ability to participate in the Promotion otherwise limited. Any such "advantage player" who is already a B Connected member prior to the commencement of the Promotion may be notified by Boyd prior to the commencement of the Promotion of any such ineligibility or limitation determination. Otherwise, any such "advantage player" will be notified by Boyd of any ineligibility or limitation determination as soon as possible after such determination is made. An "advantage player" is described as a skilled or knowledgeable player who will find legal ways to gain mathematical advantages while gambling.
- 21. Individuals who have entered any government agency self-exclusion program, or have been otherwise excluded from casinos by a government agency or Boyd Gaming or one of its affiliates are not eligible to participate.

- 9. If your machine malfunctions, please raise your hand and notify a Tournament Official immediately. He or she shall decide whether you continue to play on that machine, use a spare machine, or come back for another session. In the event of a power outage, please remain at your machine.
- 10. There will be an unlimited number of credits you can earn on your machine when you begin. The machine will lock out when the three (3) minute time period has expired.
- 11. All session scores are recorded electronically in our Tournament system. Top scores will be posted every hour, with final 14 scores & winners posted at 6:30pm.
- 12. All prizes will be paid in slot dollars and posted at the B Connected Club. All players must present valid ID to claim their prize.
