## **Swing into Power Bingo!**

## **Official Rules**

- 1. This promotion is valid at Suncoast Hotel & Casino on August 1 25, 2018.
- 2. Participants must be a B connected member. B connected membership is free and available at the B connected club. Must be 21 years of age or more to be a B connected member.
- 3. Bingo players must have a minimum buy-in for each session being played and have swiped their B connected card at time of buy-in.
- 4. Players may earn virtual drawing tickets at all sessions from August 1, 2018 at the 9:00am session through August 25, 2018 at the 3:00pm session to win a free Power Bingo entry for the Suncoast Power bingo event on September 10 11, 2018.
- 5. All drawing entries are "virtual" and will be electronically deposited into our cyber drawing drum.
- 6. Receive one (1) virtual drawing entry for every \$20 spent.
- 7. Five (5) winners will be selected by Suncoast's automated drawing system
- 8. Prize drawing for the Power Bingo entry will be held Saturday, August 25, 2018 during the 3:00pm session. Five (5) Power Bingo Entry winners will be drawn. Players must be present and playing the session to win and have a valid ID and B connected card. Winners must present a valid photo ID and B Connected card and have thirty (30) seconds to identify themselves once their name has been called. After the thirty (30) seconds have expired, a new name will be drawn until all five (5) claimed winners have been identified.
- 9. Each winner will be given one complimentary entry to the September 10-11, 2018 Power Bingo Event. Entry does not include additional purchases, optional with purchase features or other fees.
- 10. A person may only be selected to be a player once per drawing. No substitution or transfer of prize by winners permitted.
- 11. Winners are responsible for any and all taxes, transfer fees, registration and any upgrades and other fees. Winners with cumulative winnings of \$600 or more will receive a 1099 tax form.
- 12. All activated virtual entries are removed from the virtual drawing drum after the final drawing each Saturday.
