

OFFICIAL RULES

- 1. This promotion is valid at the Suncoast Hotel & Casino.
- 2. Participants must be B Connected members. B Connected membership is free and available at the B Connected Club. Must be 21 years of age or more to be a B Connected member.
- 3. Each participant will be required to pay a \$25 registration fee to enter the Blackjack Tournament. Tournament sessions are Wednesdays at 11:00am and Noon.
- 4. The Suncoast will guarantee a prize fund of \$1,000. Based on the number of registered entries this prize fund may increase.
- 5. Winners will be determined by a combined total from two sessions of play.
- 6. First place will receive 50% of the prize fund. Second place will receive 25% of the prize fund. Third, fourth and fifth place will each receive 10% of the prize fund. Sixth and seventh place will each receive a \$50 "Free Bet". Eighth, ninth and tenth places will each receive a \$25 "Free Bet".
- 7. Entrants who have earn 25 same day Tier Credits on Slots or Table Games will receive a voucher valid for (1) buffet at the St. Tropez Buffet, for any meal period which must be used with 24 hours of issuance.
- 8. All tournament play will be dealt from hand held double deck, with standard hand signals for hitting or standing. (Dealers will be instructed to have a clear and distinguishable signal from the contestant).
- 9. No strategy cards will be permitted.
- 10. As an entrant, you will play in two (2) 20 hand sessions with \$1,000 in non-negotiable, non-redeemable tournament chips.
- 11. Entrants may pay a \$5 dealer add-on for \$250 additional Tournament Chips.
- 12. Players are not allowed to "Sit Out" any hands during tournament play.

 Minimum bet is \$10. All bets must be in \$10 increments with a maximum wager of \$1,000. A remaining \$5 chip will be counted at face value for scoring only and may not be wagered in play. (In any case where "Breakage" occurs, it will be the house advantage and playoffs will be rounded to the closest possible increment).
- 13. All contestants should arrive at the tournament area for seating 10 minutes ahead of scheduled start times. Each contestant will have a grace period of 3 hands in case of tardiness (a forfeit of \$10 per hand will be assessed). A zero score will be given in those cases where the contestant was unable to participate.
- 14. Prior to play a Tournament Official will verify that all players are in the correct seats and ready to begin play.
- 15. Each round will consist of 20 hands. After completion of the 15th hand, and before the 16th hand, the dealer will count down each contestant's chips in view of all other players at the table. No other formal count will occur until the conclusion of the 20th hand. It will be the contestant's responsibility to estimate the other player's bank.
- 16. From a stack of 6 cards, the Ace card will determine the beginning 1st base position. Subsequent hands will be dealt with a rotating 1st base positioning going in a clockwise rotation. All bets should be wagered in turn beginning with 1st base, in a clockwise rotation from dealer. Once wagered, and placed in the betting area, no adjustments may be made to increase or decrease the original wager.
- 17. Suncoast's normal splitting and doubling down rules will apply.
- 18. Any hand that meets the following criteria will result in the entire hand being burned, the deck shuffled and play resumed: cards dealt out of order, customers or dealer receiving more or less than two cards.
- 19. Players are not to collaborate or consult with spectators, or assist in the decision making of other player's hands that are currently in action.
- 20. Entries are non-transferable.
- 21. Boyd may disqualify any person for any prize based upon fraud, dishonesty, violation of promotional rules or other misconduct, whether or not related to this Drawing.
- 22. Management reserves all rights.
- 23. Participants must show valid picture identification for all transactions. Valid identification is defined as a current valid form of one of the following: Driver's License (US and Canadian Only), State Issued Identification Card, including Real ID's, Military or Military/Dependent ID cards, and Passports. Photo or digital copies of any of these documents are not accepted. If player is not a U.S citizen, a current valid Passport or Green Card/Alien Registration Card is required. No other forms of ID will be accepted.
- 24. Boyd reserves the sole and absolute discretion to determine if a player is an "advantage player," and therefore ineligible to participate in the Promotion or Drawing, or to have his/her ability to participate in the Promotion or Drawing otherwise limited. Any such "advantage player" who is already a B Connected member prior to the commencement of the Promotion or Drawing may be notified by Boyd prior to the commencement of the Promotion or Drawing of any such ineligibility or limitation determination. Otherwise, any such "advantage player" will be notified by Boyd of any ineligibility or limitation determination as soon as possible after such determination is made. An "advantage player" is described as a skilled or knowledgeable player who will find legal ways to gain mathematical advantages while gambling.

- 25. Individuals who have entered any government agency self-exclusion program, or have been otherwise excluded from casinos by a government agency or Boyd Gaming or one of its affiliates are not eligible to participate.
- 26. Anyone activating Promotion or Drawing entries for any account other than their own may, at the discretion of Boyd, be excluded from the Promotion or Drawing at issue or permanently excluded from all Boyd Promotions or Drawings. Any attempt by any person to deliberately damage or manipulate any program or equipment to undermine the legitimate operation of this Promotion or Drawing may be a violation of criminal and civil laws and, should such an attempt be made, Boyd reserves the right to seek recourse against any such person to the fullest extent of the law.
- 30. Entries will be retained for record-keeping purposes in accordance with company policy and legal requirements.
- 31. Any dispute or situation not covered by these rules shall be resolved by the property's management in a manner that is fair to all parties. Participants in this Promotion or Drawing also hereby agree that all issues and questions concerning these Official Rules and the Promotion or Drawing shall be governed by Nevada law without giving effect to any principles of conflicts of law of any jurisdiction. Disputes, claims and causes of action at law or in equity arising out of or relating to this Promotion or Drawing or any prize awarded may be subject to the Dispute Resolution provisions of the Nevada Gaming Control Act and may be resolved pursuant to a regulatory decision set forth in NRS 463.361 et seq. Filed only in the state or federal courts situated in Clark County, Nevada state, and each participant hereby consents and submits to the personal jurisdiction of such courts for the purposes of litigating any such disputes, claims or causes of action; any and all claims, judgments and awards shall be limited to actual out-of-pocket costs incurred, but in no event attorneys' fees; and under no circumstances will entrants be permitted to obtain awards for third parties, and each participant hereby waives all rights to claim punitive, exemplary, incidental, special, consequential damages and any other damages, other than for actual out-of-pocket expenses, and any and all rights to have damages multiplied or otherwise increased.
- 34. By participating in the Promotion or Drawing, each winner gives Boyd Gaming permission to take photographs of each winner and use his or her name and/or likeness for advertising and publicity purposes for no compensation.
