June 2019 Table Games Hi Lo Progressive Cash Drawing! OFFICIAL RULES

- 1. The *Drawing* is valid at the Suncoast.
- 2. Drawings will be held Friday and Saturdays June 7, 8, 14, 15, 21, 22, 28, & 29, 2019.
- 3. Participants must be B Connected members. B Connected membership is free and available at the B Connected Club or the pit area. Must be 21 years of age or more to be a B Connected member.
- 4. Participants may earn entries into the Virtual Drawing beginning at 2:00 a.m. Sunday, June 2, 2019 and ending Saturday, June 29, 2019 at 9:30pm.
- 5. Table games players will earn one (1) entry for every one (1) hour of rated play with a minimum average bet of \$5 and earn one (1) additional entry for each additional \$5 average bet. It is the player's responsibility to request that their play be rated.
- 6. Additional electronic entries may be given through direct mail, e-mail, online or via text message, as well as property-specific entry multiplier days.
- 7. There is a maximum of 10,000 entries, per day, per person, for all drawings.
- 8. All drawing entries are "virtual" and must be activated (electronically deposited into our cyber drawing drum) at a casino promotional kiosk at the property where entries are earned. Participants must activate their entries at any kiosk at least fifteen (15) minutes prior to the drawing time on the day of the drawing. Entries earned during the fifteen (15) minute period prior to the drawing will not be eligible for activation in that pending drawing. Entries earned during and after the fifteen (15) minute cutoff are eligible for the next available drawing.
- 9. Suncoast will hold three (3) nightly drawings where one (1) winner will be selected in each drawing. Drawings will take place in the Table Games area with one drawing at the hours of 7:45pm, and 8:45pm and 9:45pm on the dates listed above. Participants may activate their entries beginning at 12:00pm on the drawing dates.
- 10. Winners have (2) two minutes to identify themselves once their name has been called. Identifying yourself requires the presentation of valid identification and B Connected card for all prize winners. Valid identification is defined as a current valid form of one of the following: state issued driver's license with picture, state issued identification card with picture, military identification card with picture, or government issued passport. If winner is not a U.S citizen, a current valid passport or alien registration card is required.
- 11. If the winners do not present themselves within the (2) two-minute time period, \$100 will be added to the beginning \$500 Progressive Cash total for the final drawing on June 29, 2019; 9:45pm.
