- 1. This promotion is valid at the Suncoast Hotel & Casino from March 3, 2019 March 30, 2019
- Participants must be at least 21 years old and a valid B Connected card member. Entries based on use of B Connected card. Play without a B Connected card does not qualify. Membership in B Connected is free and available at B Connected club and pit area.
- 3. Participants may earn drawing stamps toward a completed entry cards beginning March 3, 2019 at 12:01am and ending March 30, 2019 at 8:55pm.
- 4. Prior to receiving a stamp, participant B Connected number and full name must be legibly printed on the card. Once a card has five (5) stamps the completed card is eligible for the drawing and may be placed in the drawing drum in the Table Games area.
