April 2019 \$100,000 Lucky 7 Cash Promotion Rules

SUNDAY KIOSK PROMOTION

- 1. The **Promotion** is valid at the Suncoast Hotel & Casino.
- 2. Participants must be player club members. Player club membership is free and available at the players club. Must be 21 years of age or more to be a member.
- 3. At **Suncoast**, Sundays in April, participants who have earned one (1) Tier Credit beginning at 2:00 am on the promotion day, may swipe at any promotional kiosk from 8:00 a.m. through 10:00 p.m. to play the game and receive a prize. Participants must swipe for their prize by 10:00p.m. on the day the Tier Credit was earned at the property where it was earned.
- 4. All printed vouchers will include date and time issued and redemption instructions, details and exclusions. Each voucher must be redeemed within the stated time frame from issue, at the property it was earned, or the offer will be forfeited. Lost, altered or destroyed vouchers will not be accepted or replaced.

CASH DRAWINGS

- 5. The *Drawings* will be held at participating property every Friday and Saturday; April 5-27, 2019 at 6:15 pm & 8:15pm.
- 6. Participants may earn entries into the virtual *Drawing* beginning at 2:00 a.m. March 31, 2019 and ending April 27, 2019 at 8:00 p.m.
- 7. At **Suncoast**, slot and table games players receive one (1) virtual entry for every one (1) Tier Credit earned.
- 8. At **Suncoast**, participants may receive 10X Drawing entries on Tuesdays and Thursdays during the promotional period.
- 9. Tier Credit and slot points do not include spendable points, point multipliers, bonus points, or point transfers. It is the player's responsibility to make sure his or her valid player card is properly inserted into the machine and to request that their table game play be rated.
- 10. Additional electronic entries may be given as prizes through direct mail, e-mail, online or via text message, as well as property-specific entry multiplier days.
- 11. At **Suncoast**, participants may activate their entries beginning at 12:00 p.m. on drawing dates. All drawing entries are "virtual" and must be activated (electronically deposited into our virtual drawing drum) at a casino promotional kiosk at the property where entries are earned. Participants must activate their entries at any kiosk at least fifteen (15) minutes prior to the drawing time on the day of the drawing. Entries earned during the fifteen (15) minute period prior to the drawing will not be eligible for activation in that pending drawing.
- 12. **Suncoast** will hold two (2) drawing on Fridays and Saturdays at 6:15 p.m. and 8:15pm where seven (7) winners will be selected in each drawing. Drawing and the cash envelope selections will take place at the following locations:

Suncoast: Promotion area adjacent to the Race and Sports.

- 13. There is a maximum of 10,000 entries, per day, per person, for the drawing.
- 14. Participants must be present in the promotion area to win and have three (3) minutes to identify themselves once their name has been called to be eligible to play in the drawing. Valid identification and Player card is required for all prize winners. Valid identification is defined as a current valid form of one of the following: state issued driver's license with picture, state issued identification card with picture, military identification card with picture, or government issued passport. If winner is not a U.S citizen, a current valid passport or alien registration card is required. After the three (3) minutes have expired, a new name will be drawn until seven (7) claimed winners have been identified for the drawing.
- 15. In the order their name was drawn and verified, the seven (7) winners who are present will play in the cash drawing. Each winner will approach the drawing board that has 7 rows of 7 prize envelopes displayed. The first winner will choose one envelope from the top row to reveal their prize, the second winner will select one envelope from the second row and so on until all winners have selected an envelope from the prize board.
- 16. Suncoast will offer their winners the option for a 10% increase in prize value if taken as Slot Dollars. Slot dollars are non-cashable downloadable machine credits and will be available for play using your Player Card and PIN card at a single property. Slot Dollar prizes must be activated by downloading with your player card at any slot machine and will expire at 11:59pm on the fourteenth day after awarded. Slot Dollars

have no cash value, are not transferable and cannot be returned or exchanged. All Slot Dollars must be downloaded and bet at least once before cashing out. Expired Slot Dollars will not be reissued.

- 17. The cash envelopes will contain prize amounts ranging from \$250 to \$1,000 cash.
- 18. Management reserves all rights.
- 19. A person may only be selected to be a player once per drawing. No substitution or transfer of prize by winners permitted.
- 20. Winners are responsible for any and all taxes and other fees. Winners with cumulative winnings of \$600 or more will receive a 1099 tax form.
- 21. All activated virtual entries are removed from the virtual drawing drum after the final drawing each Saturday.
- 22. Boyd may disqualify any person for any prize based upon fraud, dishonesty, violation of promotional rules or other misconduct, whether or not related to this Drawing.
- 23. If, for any reason, the *Promotion or Drawing* is not capable of running as planned, including infection by computer virus, bugs, tampering, unauthorized intervention, fraud, technical failures, or any other causes within or beyond the control of Boyd which corrupt or affect the administration, security, fairness, integrity, or proper conduct of this *Promotion or Drawing*, Boyd reserves the right, in its sole discretion without notice, to cancel, terminate, modify, or suspend the *Promotion or Drawing*.
- 28. Any attempt by any person to deliberately damage or manipulate any program or equipment to undermine the legitimate operation of this *Promotion or Drawing* may be a violation of criminal and civil laws and, should such an attempt be made, Boyd reserves the right to seek recourse against any such person to the fullest extent of the law.
- 29. Entries will be retained for record-keeping purposes in accordance with company policy and legal requirements.
- 30. Any dispute or situation not covered by these rules shall be resolved by the property's management in a manner that is fair to all parties. Participants in this *Promotion or Drawing* also hereby agree that all issues and questions concerning these Official Rules and the *Promotion or Drawing* shall be governed by Nevada law without giving effect to any principles of conflicts of law of any jurisdiction. - (B) Filed only in the state or federal courts situated in Clark County, Nevada state, and each participant hereby consents and submits to the personal jurisdiction of such courts for the purposes of litigating any such disputes, claims or causes of action; any and all claims, judgments and awards shall be limited to actual out-of-pocket costs incurred, but in no event attorneys' fees; and under no circumstances will entrants be permitted to obtain awards for third parties, and each participant hereby waives all rights to claim punitive, exemplary, incidental, special, consequential damages and any other damages, other than for actual out-of-pocket expenses, and any and all rights to have damages multiplied or otherwise increased.
- 31. By participating in the *Promotion or Drawing*, each winner gives Boyd Gaming permission to take photographs of each winner and use his or her name and/or likeness for advertising and publicity purposes for no compensation.
