TIER CREDIT CHALLENGE OFFICIAL RULES

- The Promotion is valid at the Suncoast Hotel & Casino.
- Participants must be player club members. Player club membership is free and available at the players club. Must be 21 years of age or more to be a member.
- At Suncoast, April 1-30, 2019, participants who have earned Tier Credits playing Slots or Video Poker beginning at 2:00am on April 1st through the entire promotion period, ending at 11:59pm on April 30, 2019 are eligible to participate in the promotion.
- At Suncoast, slot and video poker players will achieve rank based on every one (1) tier credit earned.
- Tier Credit do not include slot points, spendable points, point multipliers, bonus points, or point transfers.
- It is the player's responsibility to make sure his or her valid player card is properly inserted into the machine and recognized. Play without a B Connected card is not valid for this promotion.
- At Suncoast, participants may view the challenge top 15 leaders throughout the challenge on a public viewing board located in the promotions area; adjacent to the Race & Sports Book.
- Suncoast will post the final results with the 15 winning account numbers in the promotions area on May 3, 2019. Winners will have 48 hours to claim their prize or the prize will be forfeited.
- There is no maximum amount of Tier Credits, per day, per person, for the challenge.
- Participants must play on their own B Connected account, tandem play or shared accounts will be excluded from the promotion.
- Winners must identify themselves and claim their prize at the B Connected club within 48 hours of the final results being posted, May 3, 2019. Valid identification and Player card is required for all prize winners. Valid identification is defined as a current valid form of one of the following: state issued driver's license with picture, state issued identification card with picture, military identification card with picture, or government issued passport. If winner is not a U.S citizen, a current valid passport or alien registration card is required.
- All winners will have the option to take their prize in cash, or Slot Dollars. If Slot Dollars are selected, the prize will be automatically added to their Players Club account within 1 hour of accepting the prize. Slot dollars are non-cashable downloadable machine credits and will be available for play using your Player Card and PIN card at a single property. Slot Dollar prizes must be activated by downloading with your player card at any slot machine and will expire at 11:59pm 30 days from the date of issue. Slot Dollars have no cash value, are not transferable and cannot be returned or exchanged. All Slot Dollars must be downloaded and bet at least once before cashing out. Expired Slot Dollars will not be reissued.

Disputes, claims and causes of action at law or in equity arising out of or relating to this Promotion or any prize awarded may be subject to the Dispute Resolution provisions of the Nevada Gaming Control Act and may be resolved pursuant to a regulatory decision set forth in NRS 463.361 et seq. Any and all disputes, claims and causes of action at law or in equity arising out of or relating to this Promotion or any prize awarded that are not subject to the Dispute Resolution provisions of the Nevada Gaming Control Act and not resolved pursuant to a regulatory decision set forth in NRS 463.361 et seq., shall be:

 - Filed only in the state or federal courts situated in Clark County, Nevada state, and each participant hereby consents and submits to the personal jurisdiction of such courts for the purposes of litigating any such disputes, claims or causes of action; any and all claims, judgments and awards shall be limited to actual out-of-pocket costs incurred, but in no event attorneys' fees; and under no circumstances will entrants be permitted to obtain awards for third parties, and each participant hereby waives all rights to claim punitive, exemplary, incidental, special, consequential damages and any other damages, other than for actual out-of-pocket expenses, and any and all rights to have damages multiplied or otherwise increased.
