## \$20,000 Table Games Hot Dice

### Official Rules

1. This promotion will run from May 3, 2019 through June 1, 2019.
2. Participants must be at least 21 years old and a valid B Connected card member. Entries based on use of B Connected card. Play without a B Connected card does not qualify. Membership in B Connected is free and available at the B Connected booth and the Pit area.
3. The customer must be actively playing a table game and being rated to be eligible for this promotion. To be rated, when you are seated at a table, please inform the dealer that you would like to be rated and they will have a floor supervisor start the process.
4. The Hot Seat winner for the hour will be determined by using the Table Games Rating System Active Player list.
5. The Hot Seat promotion will be held on Friday and Saturday evenings beginning May 3, 2019 through June 1, 2019, we will also celebrate Monday, Memorial Day on May 27, 2019, with an additional Hot Seat night during the same hours.
6. Drawings will take place 3 times a night on the nights listed above. The first drawing will be between 6-7 pm, the second drawing between 7-8 pm, the third and final drawing for the night between 8-9. At each Hot Seat drawing, one name will be drawn using the Table Games Rating System Active Player List Random Player option and the winner will get a chance to roll a set of dice. If the guest selected by the computer is not present, we will draw a replacement name.
7. The player selected will win a 50X multiplier when picked. The player will roll the dice and the amount of the 2 dice added together will be multiplied by 50, this will determine how much the player wins. Example: the player rolls 6 and 4 = 10, 10 x 50 = \$500.
8. Each rated player, actively playing on the winning table will receive a Free Bet. If the selected Hot Seat winner rolls the combination that add up 2 through 6 or 8 through 12, each rated player at the table will receive a \$25 Free Bet. If the player throws a combination that adds up to 7, each rated player at the table will receive a \$50 Free Bet. The Hot Seat winner does not receive a free bet coupon. This Free Bet coupon is valid for play on any casino table game. This promotional coupon has no cash value and may not be redeemed for cash. Coupon is good for one decision on even money bets only. If you lose your wager, this promotional coupon or coupons will be claimed by the house. If you win your bet, your coupon will be paid in live gaming chips equal to the amount of the coupon(s) you bet and the promotional coupon(s) wagered will be claimed by the house. In other words, if you bet a \$25 coupon and you win, you will be paid a \$25 live gaming chip, and not any higher amount. Live gaming chips may be re-bet or exchanged for cash. If your bet is a tie, you may re-bet your promotional coupon.
9. Participants must be present and actively playing to win. Winners have (2) two minutes to identify themselves once their name has been called. Identifying yourself requires the presentation of valid identification and B Connected card for all prize winners. Valid identification is defined as a current valid form of one of the following: state issued driver's license with picture, state issued identification card with picture, military identification card with picture, or government issued passport. If winner is not a U.S citizen, a current valid passport or alien registration card is required. After the (2) two minutes have expired, a new name will be drawn until a winner has been identified.
10. Participants may only be selected to be a winner once per night. Duplicate names will be discarded, and new names will be drawn in its place. No substitution or transfer of prize by winners permitted.
11. Winners are responsible for any and all applicable taxes. Winners with cumulative winnings over \$600 per drawing will receive a 1099 tax form.
12. Boyd may disqualify any person for any prize based upon fraud, dishonesty, violation of promotional rules or other misconduct, whether or not related to this Drawing.
13. Boyd reserves the sole and absolute discretion to determine if a player is an "advantage player," and therefore ineligible to participate in the **Promotion or Drawing**, or to have his/her ability to participate in the **Promotion or Drawing** otherwise limited. Any such "advantage player" who is already a B Connected member prior to the commencement of the **Promotion or Drawing** may be notified by Boyd prior to the commencement of the **Promotion or Drawing** of any such ineligibility or limitation determination. 14. Individuals who have entered any government agency self-exclusion program, are self-limited or have been otherwise excluded from casinos by a government agency or Boyd Gaming or one of its affiliates are not eligible to participate.

Any attempt by any person to deliberately damage or manipulate any program or equipment to undermine the legitimate operation of this **Promotion or Drawing** may be a violation of criminal and civil laws and, should such an attempt be made, Boyd reserves the right to seek recourse against any such person to the fullest extent of the law.
19. Entries will be retained for record-keeping purposes in accordance with company policy and legal requirements.
20. Any dispute or situation not covered by these rules shall be resolved by the property's management in a manner that is fair to all parties. Participants in this **Promotion or Drawing** also hereby agree that all issues and questions concerning these Official Rules and the **Promotion or Drawing** shall be governed by Nevada law without giving effect to any principles of conflicts of law of any jurisdiction. Filed only in the state or federal courts situated in Clark County, Nevada state, and each participant hereby consents and submits to the personal jurisdiction of such courts for the purposes of litigating any such disputes, claims or causes of action; any and all claims, judgments and awards shall be limited to actual out-of-pocket costs incurred, but in no event attorneys' fees; and under no circumstances will entrants be permitted to obtain awards for third parties, and each participant hereby waives all rights to claim punitive, exemplary, incidental, special, consequential damages and any other damages, other than for actual out-of-pocket expenses, and any and all rights to have damages multiplied or otherwise increased.
