



- 1. This promotion is valid at the Suncoast Hotel & Casino beginning July 5, 2019 through July 27, 2019.
- 2. Participants must be at least 21 years old and a valid B Connected card member. Membership in B Connected is free and available at the B Connected booth or Casino Pit area.
- 3. Eligibility for this promotion is based on use of B Connected card with rated play. Play without a B Connected card does not qualify.
- 4. The customer must be actively playing a table game and being rated to be eligible for this promotion. To be rated, when you are seated at a table, please inform the dealer that you would like to be rated and they will have a floor supervisor start the process.
- 5. The Hot Seat Slider winner of the hour will be determined randomly by using the Table Games Rating System Active Player list.
- 6. Drawings will take place 3 times a night beginning Friday, July 5, 2019 and every Friday and Saturday for the remainder of the month. The first drawing will be random between 7:00pm and 8:00pm, the second drawing between 8:00pm and 9:00pm and the third drawing between 9:00pm and 10:00pm. The winner will be drawn using the Table Games Rating System, Active Player List, Random Player option.
- 7. Participants must be present to win and have 2 minutes to respond. If the rated player has left or doesn't respond, we will draw another winner. Valid identification and B Connected card are required for all prize winners. Valid identification is defined as a current valid form of one of the following: state issued driver's license with picture, state issued identification card with picture, military identification card with picture, or government issued passport.

  If winner is not a U.S citizen, a current valid passport or alien registration card is required.
- Each winner will be allowed to place three game pucks, one at a time anywhere on the top of the slots on the Hot Seat Slider game board. The puck will travel through the pegs on the board and end up in a slot with a prize amount of \$50, \$100, \$150 or \$250 indicating a prize amount, the total of the three prize amounts equals the winner's prize. For example, the first puck lands in the \$250 slot, the second in the \$150 slot and the third in the \$250 slot; (\$250+\$150+\$250= \$650) the winner will receive \$650 cash. In the event the puck gets stuck or stops before reaching the prize slot, the puck will be removed from the gameboard by the drawing official and the winner will play that puck again. If the puck gets stuck or stops more than three times, that puck will be removed from play and count for \$250 toward the winner's total for that puck. Each player actively playing with a B Connected Card at the same table with the Hot Seat Slider winner will receive a \$25 free bet. This Free Bet coupon is valid for play on any casino table game. This promotional coupon has no cash value and may not be redeemed for cash. Coupon is good for one decision on even money bets only. If you lose your wager, this promotional coupon or coupons will be claimed by the house.
