

OFFICIAL RULES February 2020

- 1. This promotion is valid at Suncoast Hotel & Casino every Sunday from February 2 23, 2020.
- 2. Participants must be B Connected members. B Connected membership is free and available at the B Connected Club. Must be 21 years of age or more to be a B Connected member.
- 3. Participants who earn the required same day Tier Credits between 2:01am and 11:59pm during the promotional period may swipe at any kiosk the same day for a Eat Your Heart Out voucher. Limit two (2) vouchers of each offer, per account, per day. Up to two (2) same vouchers redeemed per table, per visit.
 - a. Earn 50 Same Day Tier Credits One (1) Dine in only, dinner buffet, excludes Sunday Brunch, breakfast and lunch. Voucher is valid Sunday through Friday of the same week earned, the day of printing is counted as 1 day.
 - b. Earn an additional 50 Same Day Tier Credits One (1) additioanl Dine in only, dinner buffet, excludes Sunday Brunch, breakfast and lunch. Voucher is valid Sunday through Friday of the same week earned, the day of printing is counted as 1 day.
- 4. Vouchers must be redeemed at the outlet they are issued for and have no cash value, cannot be sold, transferred, refunded or exchanged, and are void if altered, or reproduced. Gratuity is not included. Limit (2) two vouchers per table/check with minimum 2 guests, per visit.
- 5. Tier Credits are not affected by point multipliers, bonus points or point transfers. It is the player's responsibility to make sure his or her valid B Connected card is properly inserted in the slot machine and/or request that their table games play be rated to earn tier credits.
- 6. No substitution or transfer of kiosk vouchers permitted. No refund for expired vouchers. Cannot be combined with any other offers.
- 7. Participants must show valid picture identification for redemption of vouchers at outlet. Valid identification is defined as a current valid form of one of the following: Driver's License (US and Canadian Only), State Issued Identification Card, including Real ID's, Military or Military/ Dependent ID cards, and Passports. Photo or digital copies of any of these documents are not accepted. If player is not a U.S citizen, a current valid Passport or Green Card/Alien Registration Card is required. No other forms of ID will be accepted
- 8. Points will not be deducted from the participant's account upon redemption at the promotional kiosk.
- 9. Management reserves all rights.
- 10. Boyd may disqualify any person for any prize based upon fraud, dishonesty, violation of promotional rules or other misconduct, whether or not related to this Promotion.
- 11. Boyd reserves the sole and absolute discretion to determine if a player is an "advantage player," and therefore ineligible to participate in the Promotion, or to have his/her ability to participate in the Promotion otherwise limited. Any such "advantage player" who is already a B Connected member prior to the commencement of the Promotion may be notified by Boyd prior to the commencement of the Promotion of any such ineligibility or limitation determination. Otherwise, any such "advantage player" will be notified by Boyd of any ineligibility or limitation determination as soon as possible after such determination is made. An "advantage player" is described as a skilled or knowledgeable player who will find legal ways to gain mathematical advantages while gambling.
- 12. Individuals who have entered any government agency self-exclusion program, or have been otherwise excluded from casinos by a government agency or Boyd Gaming or one of its affiliates are not eligible to participate.
- 13. Anyone activating this Promotion for any account other than their own may, at the discretion of Boyd, be excluded from the Promotion at issue or permanently excluded from all Boyd Promotions or Drawings. Further, the holder of the account containing Promotions that have been activated by a party other than the account holder may, at the discretion of Boyd, also be excluded from the Promotion at issue or permanently excluded from all Boyd Promotions or Drawings.

If, for any reason, the Promotion is not capable of running as planned, including infection by computer virus, bugs, tampering, unauthorized intervention, fraud, technical failures, or any other causes within or beyond the control of Boyd which corrupt or affect the administration, security, fairness, integrity, or proper conduct of this Promotion, Boyd reserves the right, in its sole discretion without notice, to cancel, terminate, modify, or suspend the Promotion.

Any attempt by any person to deliberately damage or manipulate any program or equipment to undermine the legitimate operation of this Promotion may be a violation of criminal and civil laws and, should such an attempt be made, Boyd reserves the right to seek recourse against any such person to the fullest extent of the law.
- 17. Entries will be retained for record-keeping purposes in accordance with company policy and legal requirements.
- 8. Any dispute or situation not covered by these rules shall be resolved by the property's management in a manner that is fair to all parties. Participants in this Promotion also hereby agree that all issues and questions concerning these Official Rules and the Promotion shall be governed by Nevada law without giving effect to any principles of conflicts of law of any jurisdiction. Disputes, claims and causes of action at law or in equity arising out of or relating to this Promotion or any prize awarded may be subject to the Dispute Resolution provisions of the Nevada Gaming Control Act and may be resolved pursuant to a regulatory decision set forth in NRS 463.361 et seq. Any and all disputes, claims and causes of action at law or in equity arising out of or relating to this Promotion or any prize awarded that are not subject to the Dispute Resolution provisions of the Nevada Gaming Control Act and not resolved pursuant to a regulatory decision set forth in NRS 463. 361 et seq., shall be:
 - (A) Resolved individually, without resort to any form of class action; and
 - (B) Filed only in the state or federal courts situated in Clark County, Nevada state, and each participant hereby consents and submits to the personal jurisdiction of such courts for the purposes of litigating any such disputes, claims or causes of action; any and all claims, judgments and awards shall be limited to actual out-of-pocket costs incurred, but in no event attorneys' fees; and under no circumstances will entrants be permitted to obtain awards for third parties, and each participant hereby waives all rights to claim punitive, exemplary, incidental, special, consequential damages and any other damages, other than for actual out-of-pocket expenses, and any and all rights to have damages multiplied or otherwise increased.
- 19. By participating in the Promotion, each winner gives Boyd Gaming permission to take photographs of each winner and use his or her name and/or likeness for advertising and publicity purposes for no compensation. As a condition of the redemption of any prize in this Promotion, each winner further agrees to execute an affidavit of eligibility, a publicity release and a liability release, in the form provided by Boyd Gaming.
