

7FIVE Brewing Co. VIP Beer Dinner Contest Rules

1. As used herein, "Boyd" means Boyd Gaming Corporation.

 - ii. From the microsite, answer the trivia question to be entered to win.

8. One winner will be drawn for the social contest and one winner for the dine-in contest, two (2) lucky winners total will be drawn.
