- 1. This promotion is valid at the Suncoast Hotel & Casino from February 3 February 29, 2020
- 2. Participants must be at least 21 years old and a valid B Connected Club card member. Entries based on use of B Connected card. Play without a B Connected card does not qualify. Membership in B Connected is free and available at a B Connected Club or in the Pit Area.
- 3. Participants may earn drawing entries beginning at 12:01am Monday, February 3rd 8:55pm on Saturday, February 29, 2020.
- 4. Participants will be given a Drawing Entry Card and will receive one stamp for every qualifier. Qualifiers are:
