February 2020 - Play & Dine

OFFICIAL RULES

- 1. This promotion is valid at Suncoast Hotel & Casino every Thursday from February 6 27, 2020.
- 2. Participants must be B Connected members. B Connected membership is free and available at the B Connected Club. Must be 21 years of age or more to be a B Connected member.
- 3. Participants who earn the required same day Tier Credits between 2:01am and 11:59pm during the promotional period may swipe at any kiosk the same day for a Play & Dine voucher. Limit one (1) voucher of each offer, per account, per day. Up to two (2) same vouchers redeemed per table, per visit.
 - a. Earn 20 Same Day Tier Credits One (1) Dine in only, breakfast or lunch buffet, EXCLUDES dinner & SUNDAY BRUNCH. Voucher is valid for 7 days from the day the kiosk voucher is printed, the day of printing is counted as 1 day.
 - b. Earn an additional 200 Same Day Tier Credits One (1) Dine in only \$20 Dining Credit valid at Dupar's, Brigg's, Peng Zu, SC Prime or 90 NINETY. Voucher is valid for 7 days from the day the kiosk voucher is printed, the day of printing is counted as 1 day.
- 4. Vouchers must be redeemed at the outlet they are issued for and have no cash value, cannot be sold, transferred, refunded or exchanged, and are void if altered, or reproduced. Gratuity is not included. Limit (2) two vouchers per table/check with minimum 2 guests, per visit.
- 5. Tier Credits are not affected by point multipliers, bonus points or point transfers. It is the player's responsibility to make sure his or her valid B Connected card is properly inserted in the slot machine and/or request that their table games play be rated to earn tier credits.
- 6. No substitution or transfer of kiosk vouchers permitted. No refund for expired vouchers.
- 7. Participants must show valid picture identification for redemption of vouchers at outlet. Valid identification is defined as a current valid form of one of the following: Driver's License (US and Canadian Only), State Issued Identification Card, including Real ID's, Military or Military/Dependent ID cards, and Passports.
